31st, at 10:00. It will be quite abbreviated. The band has not  
been active because of Covid and everything. Mr. Dietz says  
he's still trying to find someone to give the—associated with  
the church because the one he had lined up has health issues.  
But we're working on that. There will be a Memorial Day  
service.  
I'll be asking for a couple executive sessions this evening.  
And, also, a meeting or two ago, Fire Chief Eastham had  
brought up about govdeals.com. He thought that everybody  
was somewhat favorable towards that to dispose of surplus

and unneeded Village equipment. So, based on that discussion, there will be a small article for the residents, part of my Mayor's report in the newsletter, which is at the printer right now, letting them know the Village has unneeded—as far as equipment and stuff like that, Village property. They can start looking at govdeals.com. That's it for the Mayor's report.

CHIEF EASTHAM: No report tonight.

MAYOR HILL: Questions for Travis?

MR. RADTKA: Travis, on this for the auction, govdeals, are you going to bring this through committee or—

CHIEF EASTHAM: Well, that was the thing I wanted Council to try to talk amongst yourselves, so how do you want to handle it? Because a lot of it is—there's stuff from every department down at Kunkel. I know Ron is tied up, so that's why I kind of volunteered. He's trying to catch up. I said I'll help get rid of what's in Kunkel. From there, I think it should be each department head after that. They want to run something through their committee and they decide to get rid of something. They can post it. They can sell it. But the majority of what is up there is from every department in this Village. And it's kind of wasting away and I don't like seeing it. And it would free up some room in the buildings. There's quite a bit of money up there, I feel, and stuff that can be—

MAYOR HILL: Recycled.

CHIEF EASTHAM: —sold, right. Someone can use it.

MR. BLANK: Paul, shouldn't we have legislation then authorizing that to be done?

SOLICITOR DUTTON: We have an existing policy that talks about disposing of unused property.

MR. BLANK: I mean about joining this .gov because—

SOLICITOR DUTTON: Right. You would have to amend—

MR. BLANK: —there's some expensive things up there.

SOLICITOR DUTTON: —that policy to include this website, this entity, as an approved website to dispose of that property.

MR. BLANK: Get me some information. We'll get legislation together.

SOLICITOR DUTTON: Just get us the who, what, where, when, and why of this.

MR. RADTKA: Can you get that to him, Travis?

CHIEF EASTHAM: Yeah, I gave it to them—

SOLICITOR DUTTON: Do we have to pay a fee?

CHIEF EASTHAM: No. You can choose how you want it. The one that they recommended us using is what they call zero, twelve and a half. We pay zero, the buyer pays 12 and a half percent fee—

SOLICITOR DUTTON: Premium—

CHIEF EASTHAM: —yeah, premium. We have no cost. So, whatever we sell— we sell for \$100—

SOLICITOR DUTTON: And you have a document—

CHIEF EASTHAM: —we'll get \$100.

SOLICITOR DUTTON: Get it to Bill, and get the Ordinance that we currently have.

CHIEF EASTHAM: There's an actual contract. You can take it.  
(Chief Eastham handed a document to Solicitor Dutton.)

SOLICITOR DUTTON: If we have to sign a contract, yes, we do need legislation.

MAYOR HILL: Any other questions for Travis?  
(NO RESPONSE FROM COUNCIL.)  
Parks, Grounds, Buildings, Street Superintendent, Mr. Hickox:

MR. HICKOX: Thank you, Mayor. Today the crews were busy. We poured foundations for headstones.  
And, we filled the hole in the shop floor where the old lift was removed. We're moving forward with the new lift. And it should be installed on June 8th, unless they have a cancellation and they get to us sooner.  
We're still mowing roadsides, parks and grounds.  
Our scrap tire drop off is June 7th to the 11th.  
We have removed the overgrown shrubbery in front of the benches at Salt Springs and Tod Avenue. We will replant those shortly with new plants.  
I ordered new American flags for Salt Springs Road from the Administration Building to the school and will have those up and ready for Memorial Day.  
That's all I have to report.

MAYOR HILL: Any questions for Ron?

MAYOR HILL: I do have one, Ron. Tell them about our braided cable, which was run for the lift.

MR. HICKOX: When I started—in fact, before I started, I was taken out in the shop and shown the old lift that was laying there on the floor. The wire overhead that was to come down to feed the lift, never—it's 12, 14 feet off the ground—never thought anything of it. And we have an electrician that is one of our seasonals. He's retired from General Motors. And, just in passing, I asked him if he would be willing to hook the new lift up—the wire is right there—when it comes in. "Sure." He said he'd stop up and take a look at it. He did and then he went over the electric panel where the other end of the wire is. And what is there is a steel braided conduit, more or less, with no wire in it. We were billed for wiring, a breaker and everything for this new lift. I called the electrician and he was to stop out today and look at it, and I haven't seen him yet.

MAYOR HILL: I just thought that was kind of interesting and Council ought to know about that. We got a braided cable but no wire in it.

MR. HICKOX: No wire and no breaker.

MR. BOND: Yes. I think Council should all be aware—probably are by now—Don Reider and I went to LaFarge the other day to talk to them about the roadway, at Bill Blank's suggestion, because the trucks are tearing it up. And I'm glad to report that they're going to assist us with that and take care of the expense. Bill may want to fill in a little more about how it's going to occur. I know they talked with him on it.

MR. BLANK: Yeah I did, and I forgot to bring that up, Bob. They want to make payments over four months. Trumbull County is going to do the work, correct?

MR. BOND: That's my understanding of it, yes.

MR. BLANK: So, due to the fact that we get about \$120,000 a year from tipping fees from them and they said they were going to do it, I'm sure they're going to make the payments. The guy was more than willing to take care of it.

MR. BOND: That's a sizeable savings to us.

MAYOR HILL: Absolutely. Any other Council remarks?  
(NO RESPONSE FROM COUNCIL.)  
I guess I got one. In talking with Street Commissioner Hickox, our ball fields need a little bit of work up there. In talking with former employee Dave Harrison, who is one of the coaches for softball—and Ron, Ron brought up, you know, you think the school would want to help us out to get the fields back in shape? If I say something wrong, Ron, please feel free to jump in. It was estimated to have a contractor come in, \$600 per field, do the work. And Ron estimated about \$600 for the—

MR. HICKOX: The baseball mix—

MAYOR HILL: Baseball mix. So it would be about \$1,200 a field. I did call the Superintendent and asked him if they would like to help us out on this due to the fact that the school does use our ball fields and everything. They feel somewhat favorable. They did have a workshop and the Board had a couple questions, like how soon we were wanting to get it done. We said we'd like to get it done fairly soon. I know Dave Harrison, the coach, said he'd like myself and Ron to go over and see the fields over at Brookfield because I guess those fields are in excellent shape. Ours, I guess, every time they drug it, rather than having a little crown, all the dirt is around the edges of the field. So we're going to have to get it brought back in and get our fields back in shape. Pending the School Board reviewing it, I believe it's going to be on their agenda by Wednesday. We feel they may do half the cost of getting the fields brought back together. Working with the school and the way the Superintendent said is, you know, they use our fields, our guys line them. We open the restrooms. We clean the restrooms and everything. They felt that we have a shared-services agreement. I believe that will, but we won't know for sure until Wednesday. Any other Council
