Mayor's report. By Council rules, I'm obligated to give a state-of-the-village address first meeting of the year.

We have had a lot of activity in the Village. Ultium Cells is going fast and furious with their \$2.3 billion, three-million square foot battery plant. They're also advertising already for help. So, it looks to me like they should be on track for a year from now to be starting to wrap up operations.

TJX Homegoods. I believe that they're —in the next two months, they will be doing hiring. They're already looking at new employment.

Lordstown Motors. We keep getting more and more news out of that every day. If you haven't seen, they are now going to use Camping World as their service centers, about 170 of them across the U.S. So, they're putting their network together. I know some people have apprehension, but it looks to me like things are going forward.

Old Dominion Trucking. I'm not sure what the completion date is, but they're moving forward.

They're still working on the second power plant. The first one has been running for a little over two years. They're still wrapping up—I believe they're looking for the debt now. I believe they have most of the equity wrapped up for the second power plant.

We have been working in the Village—we haven't had any capital improvements lately except for what we have just needed to get by due to the lack of income. However, I did

get a call from the State, and we will be getting some of the claw back money, which General Motors had to pay back when they had gotten the \$60 million tax credit years ago for their plant. And there was an agreement. There should be an announcement, I believe, within the next two weeks how much we're getting. I was told a number, but I don't want to pass that on until it's verified.

M&M Containers is moving into the Magna building. They make plastic containers for a variety of companies. This will be their fourth facility. They're based out of Chattanooga,

We did get a new water agreement with the City of Niles to prepare us for the future. I've got to give Cindy at the Water Department a big atta girl for that one because she got a lot of hours in on that.

Due to the fact that Ultium Cells is coming into town, we are seeing about getting a new three-million-gallon water tank. Those negotiations have been ongoing, very slow, but ongoing. Hopefully, we'll be getting that ramped up here shortly.

We're getting new dispatch equipment for our dispatch through some of our CARES money. That should be starting real soon.

We are trying to prepare the Village for the future. We have had a lot of lookers, tire kickers, looking at our properties.

We are well situated. When I first talked to TJX

Homegoods, they said whenever they do studies, a lot of companies do kind of follow. And if you've been following the news or any of the commercial realtors or the Chamber or anything, we are designated a hot spot.

We put on a full-time Fire Chief, which may have been overdue. He does an excellent job. He's got us a lot of grant money, and we appreciate the job he did, and it was time because we're growing.

I got a copy of the budget, the appropriations, from the Clerk. Now, some of this includes approximately \$12 million, which is put in from General Motors. But the total appropriations for 2021 are \$23,639,832.61. That just came from the Clerk's office. All the monies are appropriated there.

Our income tax collections in the last year, \$1,718,294.82. That is quite low from what we were used to, but in working with the Clerk and the Finance Committee, we have held the line, and we look forward to better times ahead.

Also, under new business, everybody should have had in their box committee assignments.

Also, I've got about seven resumes for the position of Street Commissioner. Dale Grimm will be retiring at the end of January. So, I'll ask Council to appoint him for the month of January.

We'll be asking for approval of the committees and also for Council President pro tem.

That is it for the Mayor's report. I look forward to this year. I think this year will be a good year. We'll see what it brings.

Is there a Clerk's report?

MR. BLANK: No, you brought up what I was going to bring up. Just like

you said, the general fund is \$600,000, carryover \$600,000 less than the previous year. Better than what I thought it was

going to be.

MAYOR HILL: Thank you. Solicitor's report?

SOLICITOR DUTTON: No report.

MAYOR HILL: Thank you. Treasurer's report?

MR. EBLING: No report.

MAYOR HILL: Thank you. Board of Trustees of Public Affairs report?

MR. DIETZ: We're working on stuff with CT. MAYOR HILL: Okay. Thank you very much.

Village Engineer is not on, so we can't ask for his report.

Special reports. Police Chief Milhoan?

CHIEF MILHOAN: Yes, Mr. Mayor. I've submitted my monthly report for

December, along with my yearly report for 2020. If you

have any questions, I'll answer them.

MAYOR HILL: Are there any questions for Brent?

(NO RESPONSE FROM COUNCIL.)

Thank you, Brent. Fire Chief Eastham?

CHIEF EASTHAM: No report, Mr. Mayor.

MAYOR HILL: Thank you. Any questions for Travis?

(NO RESPONSE FROM COUNCIL.

Planning and Zoning Administrator and Director of

Economic Development, Kellie?

MS. BORDNER: Yes, Mr. Mayor. I provided everyone with some zone map

changes and that will reflect three zone changes which were all in June of last year. It's kind of a recapitulation of our zone changes and it goes clear back to 1980. We will

continue to add on to that as things change.

I also provided a zoning permit report for 2020. And that shows permit fees of \$323,224.57, which we collected this past year. And the Fire Chief, the Clerk and I have entered the information for the CARES Act grant funds that we have received as required. That has been accepted, and we are

good to go on all of that.

MAYOR HILL: Thank you very much. Are there any questions for Kellie?

Excellent report. Thank you.

MAYOR HILL: Parks, Grounds, Buildings, Street Superintendent, Mr.

MR. LIMING: No, but I'd like to commend the Street Department on the

Christmas Eve and Christmas Day snow removal. They did

a good job.

MAYOR HILL: I can concur with that.

MR. LIMING: Excellent job.

MAYOR HILL: I know I've talked to Mr. Reider and if you were heading

south on Bailey Road out of Lordstown, the second you hit

Bailey Road, I'll tell you what, it was a disaster.

MR. LIMING: You can tell exactly where the county line was, any road

you're on.

MAYOR HILL: Yes, you can.

MR. BOND: My daughter and her husband were coming in from out by

Randolph, and they said the same thing. Bailey Road south

of the county line was a mess.

MAYOR HILL: It was horrible. I concur. Thank you, Dale.

Bill, is there any correspondence this evening?

MR. BLANK: No correspondence, Mayor.
