It came down to two. I had some dialogue with the other two, and my recommendation is Mr. Hickox, who is here this evening. Everybody should have had a copy of his resume in their box. If anybody has any questions—if anybody would like to ask questions now before—I'll be asking Council to confirm his appointment under new business. He should be able to come in and hit the ground running. We have a lot of

paving projects we're hoping to be coming up. He has a lot of experience. And I'll entertain Council's motion to put him on effective February 1st. Any comments or questions on

that?

MR. KEVIN CAMPBELL: Well, we just finished our meeting tonight. I want to make

sure that, you did mention, we have a couple appointees and some clarification that we're not adding positions. I know there was some confusion and questions on that. But there's

no additional personnel being added with that request.

Planning and Zoning Administrator and Director of

Economic Development, Kellie?

MS. BORDNER: Yes, Mr. Mayor. In your boxes, I put a report from 2020 of

the subdivisions and consolidations that occurred during last year. I also put in a 2020 report of real estate transfers. That should conclude our 2020 report for the Planning and Zoning Office. If you have any questions, I'd be happy to answer

them.

back from Pittsburgh about 4:30 from the Police Chief. It's

renewal of emails. I'll read it. It's short. "To Safety

Committee. I was just informed by Joel Davis, our IT guy, that our employees' emails, which it provided through Office 360 GoDaddy, will expire on January 26, 2021. We will need to renew this in order to keep our employees' emails active. We have an option of a one-year renewal, two-year renewal or three-year renewal. Joel Davis checked to see if they offer a price break for a two-or three-year renewal, and they do not. The cost per year is approximately \$2,803 and some change. Please advise if you'd like to renew for one, two or three years." I don't know how many email addresses this is. Chief, are you there?

CHIEF MILHOAN:

Yes, I am. It's for all the officers full time, all the dispatchers full time and all the auxiliary officers and part—time dispatchers. There's somewhere around 25 to 30 employees.

MR. BOND:

Okay. Is it so much per email address or how is this figured out to come out with this total? It seems like a lot of money

for an email address to me.

CHIEF MILHOAN:

I believe it's so much per range.

MR. BOND: CHIEF MILHOAN: Why does it cost so much to get an email address?

I couldn't answer that. That was set up through Joel, and we add and delete employees as they come and go. That was what he recommended. We had no problems with it. And, at this point, I'd hate to change because our emails are all set

up, everybody has them.

MR. BOND:

I see. It just sounds like, to me, a lot of money for some email addresses when a lot of places even offer them free and free archiving.

Now, do you know what the ranges are? Because I went to the department website. I saw three of them listed there and one of them was for the Chief, yourself; one for the Captain, and one is for the Detective. I think the Detective and the

Captain are the same person, aren't they?

CHIEF MILHOAN:

Those are the ones that were originally set up when we first had email. When we started our email system, we only had three. We saw there was a need for everybody to have an email system, and that's when the GoDaddy accounts were

set up. All the employees were given emails.

MR. BOND:

Okay. I just wondered since this expires on the 26th. We're not going to have another meeting between then and now. That's the reason I brought it up now. It would have to come through Council as a Whole, because I didn't receive this until—you sent it at 2:17 p.m., Chief, and I got it at about 4:00. Does anybody on Council have any thoughts on this?

MR. BLANK: How much was it last year?

MR. BOND: Is that the same price it was last year?

CHIEF MILHOAN: I believe it was. I'd have to double check with Joel. But I

emailed you when I got the phone call from Joel—

is many of those sites are not secure. And there's a lot of other benefits he said to going with this. It's a little bit above my head, but I guess if you want to have him come to a meeting and explain it better, that would probably be my recommendation if that's the direction you want to go.

MAYOR HILL: Okay, Bob, that help you out?

MR. BOND: Not a whole lot. What was the promotional rate?

CHIEF MILHOAN: Bob, he did not have those numbers with him. He did say the

cost is per email. He didn't know what the cost was for the first three years. He just knew it was a lower rate. How much lower, I don't have those numbers right now.

available. To me, it just seems like a lot of money for an email address. I don't know what anybody else thinks about

it.

Governor Husted had told me was that was the state's money. And they wanted to put money back in the valley. And he said that that is where it went. They had a group of people look at it, which wasn't what Bill had taken from the phone call he got, but he said that they wanted to put \$12,000,000 back in the valley. They could have put that in the state coffers if they wanted it. You know, it wasn't something which could just be given to us. He said that they want to be able to work with General Motors. They did get all the GM and other incentive package to keep them here. That wasn't our money to begin with. He said that no entity got direct funding. Now, I will say there's, like, 2.5 million in Eastgate, which could go toward infrastructure improvements, and we may be able to go for some of that. But he said that when the \$3,000,000 came in, that's where it got allocated. There was a lot of talk through the Department of Developmental Services. And he

directly, and that's how it got allocated.

MR. BLANK: He did tell me that the Governor himself and GM was in

favor of giving money to the Village.

MAYOR HILL: And that's what I believe because they were not aware that

General Motors had already, you know, committed to the water project, and he said that, basically, it is what it is.

did stress that that money was not out of the Village coffers

MR. BLANK: Like you said, he said they didn't have to give that money up.

They're right. But that was caused from General Motors pulling out early and you're rewarding them with \$3,000,000.

That don't make sense to me, at all.

MR. BOND: That has definitely hurt our Village.
