CHIEF MILHOAN:

Yes, Mr. Mayor. I have a number of items tonight. I submitted my monthly report for January, 2021. If you have any questions, I'll attempt to answer them.

Second thing is, prior to the meeting, I passed out some papers to member of the Council and Mayor and also the Clerk. I realize that we're not in a position right now to purchase police cruisers, but I wanted to give you information, in the event in the near future or at some point, we do become in the position to make a purchase for police cruisers.

The first paper that I gave you is an inventory of the cruisers that we had, our entire fleet, roughly about two and a half years ago. It shows the make, model, mileage, car number and the officer that was assigned to that car.

The second paper, which is today's inventory, basically shows the same fleet, but you can see we're down about five cars, along with the mileage on the side. If you notice, on the first page, we have three cars that were shared by our auxiliary officers. We currently do not have that anymore.

What that means is the cars that our auxiliary officers used to drive are now driving the cars that our full-time officers are driving, which is 32, 33, 34, 35 and 36. On occasion, some of these cars can go eight, nine shifts in a row and never shut off. They're used shift after shift. So, obviously, it doesn't take a rocket scientist to figure out what's going to happen with mileage. So, we're going to go through those fairly quickly. The first two cars on the list, car 5 and car 26, I can tell you are in pretty bad shape. Car 5 is driven by our Captain. It's an unmarked vehicle. There's so much rust on the tailgate that every time he closes the lid, part of the car is left in the parking lot. I'm not sure how much longer we're going to get out of this vehicle, but we'll try to do the best we can. We did buy the vehicle used.

The second car, car 26, is not an actual patrol vehicle. It's the car that our School Resource Officer, Dave Harrison, uses. According to our mechanic, the rear end in that is about ready to go out. So, again, we'll try to get what we can get out of that. The other cars, to my knowledge, are mechanically sound at this time.

The last paper shows you the cost of a 2021 Chevy Tahoe and a 2021 Ford Explorer. The first figure is what the base price of the car is. And then the figure to the right is approximately the upfitted total cost. You'll see the Chevy Tahoe—if you're going to purchase one—under state purchasing, the orders must be placed by March 25.

Obviously, you can still get a Chevy Tahoe after that, but you're at the mercy of whatever the dealership has, and you probably won't get state purchasing—or you may not get state purchasing. You may pay more.

The Ford Explorer has a different order date. All the information is there. Again, I realize we're not in a position right now to place an order. But, again, it was just for informational purposes. I just wanted you to have the information in the event that, you know, whenever that time

comes that we can move forward.

The difference between the two cars is roughly about \$5,000. Any questions before I move on?

MR. BOND:

Yes. These are the only two vehicles you would consider appropriate for a cruiser?

CHIEF MILHOAN:

Yes. Anybody else?

The next item. On the 8th of February, I received an email from a gentleman by the name of Dave Patrick. He was expressing his displeasure with the fact that the train is blocking the road at the crossings at Salt Springs and Muth and Salt Springs—or, I'm sorry, Lyntz and Muth. We're all aware of the situation there. I responded back to his email. Gave him all the case law and everything that I have on the subject. I explained to him that we are also frustrated. He responded back and thanked me for responding to him, but asked if I would bring before Council his suggestion. And I'll read his response to you. It's pretty short. "Thank you for your response and I appreciate your frustration along with mine. I sat for 57 minutes yesterday, which ended up costing me a lot of money by the end of the day. If Lyntz Road was open to truck traffic east of the rail to Route 45, we wouldn't have an issue. It's just maddening to me to have approximately three hours of my legal off-duty hours over the last week because of waiting at the same crossing." Basically, this guy is a truck driver, and he was leaving TDSI with a haul, got held up. And, according to him, it ended up costing him money. His suggestion is if he could come out of TDSI and make a left on Lyntz and head east to Tod Avenue. I'm sure that's not something you probably want to consider. I would imagine the residents that live on that road would not be happy with that, but I did express to him that I would bring it before Council. I did speak briefly to the Mayor about it. He asked me to bring it before Council as a whole. If you have any concerns or thoughts or suggestions—I'm pretty sure if we started running trucks down that way, it would not only damage the road more than it is, but it would also infuriate our residents. But I did express to him that I would bring it before Council, and I would get back to him on your response. So, if you want to let me know either now or in the near future, I do need to get back with this gentleman. Anybody?

MAYOR HILL:

They can give you a call.

MR. RADTKA:

And, if we're going to have a Roads meeting maybe next week, we can discuss that at the meeting.

CHIEF MILHOAN:

Okay. Last thing I have—actually, two things. I would ask for approval for Mason Marinkovich to be put on as a part-time dispatcher. Mason is a part-time dispatcher with Niles at this time. I believe with his experience at Niles, he would be ready to be working on his own rather quickly. As the Mayor mentioned earlier, we are removing Hailey Armstrong. She's asked to be removed. So, this would help us out in our part-time dispatcher status.

Last thing I have is, as you know, we recently remodeled our dispatch center. It came out very well. If any of you would

like to stop—I know Terry Campbell has seen it—but if any of you would like to stop and see what it looks like. We're very pleased with how it worked out. Jake Hudson from Hudson Communications did exactly what he said he would do. I know that sometimes doesn't happen when you're dealing with contractors and things like that, but he did a great job. We completely gutted our dispatch center and redid everything, new console. It really came out nice. I also want to publicly thank the Trumbull County 911 Center interim director, Patty Goldner, and Roger Laird. What they did is they provided us a workstation at the 911 Center for eight days. We sent our dispatchers out to Howland, and they dispatched our police and fire and Warren Township police and fire, and we had no hiccups at all. They were very accommodating to us, and it worked out well.

The other thing they showed us is that if we ever had a disaster at our building, we could still function from their facility. So, it was kind of to test the system, if you will, so it worked out well.

The last few people I want to thank is Fire Chief Eastham. Travis was instrumental in getting this kind of off the ground, this remodel off the ground. Captain Chris Bordonaro was very instrumental in following the project through. Our Street Department helped out with painting and getting the room ready. And our IT person, Joel Davis, did a wonderful job, too. So, if you'd like to stop in and see it, please come up. I'd be happy to show it to you.

By correspondence, I have an application from the Geauga/Trumbull Solid Waste District for a scrap tire day if we are interested. We qualify for a grant of \$1,562, which basically covers the cost of the dumpster and the disposal of the tires. There is no reimbursement for labor or anything. That would be at the Village's expense if they wanted to have it. Just looking for feedback to see which way the Village wants to go on it. I understand, in the past,

we did pass on this last year and maybe a few years before that. If it's something we want to start again, I'll get the application filled out and in. If not, we can just table it.

MR. BLANK: Ron, it was my understanding when we did away with recycling containers, we weren't entitled to that anymore.

MR. HICKOX: I called the District Administrator, Lisa Smith; and she said, yes, we do qualify for it even though we're not in the recycling program.

MR. BLANK: We would have done it last year if we'd have known that.

MR. RADTKA: We chose not to do it last year because of what Bill said. But we might want—

MR. LIMING: If we want to do that, we can, especially since we took a year off.

Got another request. Here years ago we had a lot discussion about the road in front of GM Lordstown. And we put signs up for "Honorary GM UAW Parkway." I've been asked—I know when you get off the Turnpike exchanges, they still had some GM signs there on the Turnpike property. And I have been requested by Lordstown Motors if we would want to designate that section—it was an honorary designation because we had a lot of discussion whether we wanted to change the name. We didn't want to do that—call it "Voltage Valley Parkway." You know, put some signs up because of all the electric issues in the Village. They asked if Council would want to do that, you know, allow them to put it up. You know, I haven't talked to them, but I would assume that they would pay for them.

MR. RADTKA: That was the only question I had. I don't have a problem with it.

MR. BOND: You mean to change the name or it's an honorary name or are they just going to put signs up or what?

MR. RADTKA: Honorary like it was before—

MAYOR HILL: Like it was before. We had signs there, Bob, where it said "Honorary GM—

MR. BOND: On the Turnpike, they had a different sign.

MAYOR HILL: Theirs said GM—
