the last time I tried to do it, I got two volunteers. So, needless to say, we didn't have that. I know when the previous Mayor tried that once or twice, the only people he had to help him out were the department heads. So, you know, I'm wondering if Council thinks we ought to put like

an all-call for Earth Day and see if we can get in coordination with the Road Department. We can always get

bags and vests and stuff like that. Any comments from

Council on that?

Just throwing that one out there. They did offer to come clean some roadsides. We do have some pretty polluted roadsides from the winter. So, I guess we'll have to take a

look and see where that's at.

There are six appointments for summer help. That's it for the

Mayor's report. Clerk's report?

CHIEF MILHOAN: Yes, Mr. Mayor. I've submitted my monthly report for

March if you have any questions.

MAYOR HILL: Any questions for Brent?

Fire Chief Eastham?

CHIEF EASTHAM: No report tonight, Mr. Mayor.

MAYOR HILL: Questions for Travis?

(NO RESPONSE FROM COUNCIL.)

Planning and Zoning Administrator and Director of

Economic Development, Kellie?

MS. BORDNER: Yes. Thank you, Mr. Mayor. We have a Planning

Commission meeting on Monday, April 12, at 6:30 p.m.

MAYOR HILL: Questions for Kellie?

(NO RESPONSE FROM COUNCIL.)

Parks, Grounds, Buildings, Street Superintendent, Mr.

Hickox?

MR. HICKOX: Thank you, Mr. Mayor. The past two weeks—the main part

of our last two weeks, anyway, was replacing a culvert on Highland Avenue. County Engineer sent us out an excavator and an operator that knew what was going on, and he took charge, and we were able to get that completed in five days as opposed to nine. We still have to pave it and the paving plants have opened today, so we're hoping to get that shortly, weather dependent now. We're going to ask the County Engineer for assistance on that. They have the paving

equipment.

The next item I have is it's time for us to order our salt—not necessarily order but commit to how much salt we'll need for next year. The County Engineer, in the past, has told me

we've always made sure we had 2,000 tons available to us. We still have 700 tons left from last year. So, for the '21, '22 season, I would recommend that we reserve 1,300 tons. The cost will be determined through the state purchasing program and that won't happen until September, October, later on this year. So, if it's okay with Council, I'll go ahead and reserve us 1,300 tons or let me know what you want me to do.

MR. LIMING: Are we going to be doing 45? Is that 2,000 ton for doing 45?

MR. BLANK: It's not supposed to be.

MAYOR HILL: Normally, I thought the state gave us salt for 45.

MR. HICKOX: I was told they gave us 500 tons when we were doing 45.

So, I just took that 500 tons just out of the equation.

MR. LIMING: Oh, okay. I'd say better get the—

MR. HICKOX: Do the 1,300?

(Multiple affirmative responses.)

MR. HICKOX: Okay. I'll take care of that tomorrow. That's all I have.

MAYOR HILL: Any other questions for Ron?

(NO RESPONSE FROM COUNCIL.)

Hearing none, Bill, do we have any correspondence this

evening?

MR. BLANK: No correspondence, Mayor.

MR. DIETZ: Tom Dietz, 2821 Hallock Young Road. I'm asking the

Council to support the Memorial Day flowers and the wreath. The Mayor was supposed to ask the Fire Chief if he thought we could have one this year. I talked to the school already. He said no band, but he will get us a trumpet and some flag bearers. And Ron will get the crosses out for us if we don't have anybody. And it will probably be \$200 for the

flowers and the wreath.

The next one is the fall festival. They are going to try to have one. Do we have the money for the fireworks this

year?

MAYOR HILL: Bill, you want to answer that? MR. BLANK: We have money for that, Tom.

MR. RADTKA: You want to bring that up through committee.

MR. BLANK: You can. I think the legislation is still good. But if you want

to bring it up to committee to discuss it, you have time. I

don't know when they need to know by.

MR. RADTKA: How soon do you need to know, Tom?

MR. DIETZ: Well, Sue got ahold of—what's the dates? She didn't tell me.

CHIEF EASTHAM: 24, 25, 26.

MR. BLANK: Ron, the Ordinance, I believe, is already in effect, so there's

really nothing you can do about that, nothing to discuss if the

Ordinance is still good, and I think it is.

MR. DIETZ: But it's all going to depend on what the state says. But we're

going to try to have one. The school said we could use the

building for the-

MAYOR HILL: Crafts.

MR. DIETZ: Craft show. I'm sorry. My memory—

MR. BLANK: Ron, if that expired, let me know tomorrow. I don't think it

did.

MR. RADTKA: Well, you want to hold off talking until we find out what the

state is going to let us do?

MR. DIETZ: Well, we've got to start making arrangements, sending out—MAYOR HILL: They have to set up fireworks and rides and let people know

that we're going to have it in case they want to have crafts

and all of that.

CHIEF EASTHAM: As of right now, all fairs are a go. The Governor lifted

everything for fairs with social distancing, masks, and I'm sure with their Porta Johns, they'll probably have wash

stations, hand sanitizers—

MR. DIETZ: Yes.

CHIEF EASTHAM: It will be mandatory. But other than that, as of—the first fair

usually doesn't start until around June time frame for the

state.

MR. DIETZ: And ours in September is the windup of everything.

CHIEF EASTHAM: So, they're trying to push everything out.
