Mayor's report. Due to the fact that we're meeting live, and our Zoom extended contract has expired, this will be our last

Zoom meeting. The rest of them will be in person.

And everybody should have two appointments. One for the Utility Department for summer help, and the other one for junior firefighter. So, I'll be asking Council to confirm them under new business. That's it for the Mayor's report.

Is there a Clerk's report?

MR. BLANK: No report.

MAYOR HILL: Solicitor's report?

SOLICITOR DUTTON: No report.

Treasurer's report? MAYOR HILL: MR. EBLING: I have no report.

MAYOR HILL: Board of Trustees of Public Affairs report?

MR. SULLIVAN: We had a special meeting to pass several Resolutions for you

> to pass tonight. So, when the money comes in from the contractors, Bill can pay it. So, we'd appreciate if you would

pass those tonight.

MAYOR HILL: Thank you, Mike. Any question for Mike?

(NO RESPONSE FROM COUNCIL.)

Village Engineer's report?

MR. KOGELNIK: We've completed this past month that review for Fear Forest

> and also we are, I guess, waiting for documents to roll in from M&M Industries for their second phase of their plan review. So, we'll do that. I think the Clerk has a copy of the work authorization for the second phase, so we should get going on that as soon as they supply us with the documents. The only other thing that we're working on, on Ultium

tomorrow we have some sanitary sewer testing to do. Thus far, their sanitary sewer improvements—this is the line that connects their facility to Trumbull County interceptor—it looks like it's going well. We've got a small punch list of things that we've worked on with them. And they have been pretty expeditious about trying to address each and every one of those. So, tomorrow we're testing the meters. Those are the meters that measure the flow going into the interceptor

They've also addressed—or begun to address—some of the dust complaints that we talked about. Of course, we just got hit by a little bit of a rain today so that should be dissipated. But, I encourage you to reach out to the staff at Gresham Smith in the event they have another issue with dust and advise them that you're experiencing something because you shouldn't have to with that project. That's all I have. Do you have any questions for me?

MS. BORDNER: MR. LIMING: MR. KOGELNIK: Hallock Young-

Anything more on Hallock Young getting opened up? Oh, the relocated section. Thank you, Kellie. Nothing yet. They claim that they are moving expeditiously on their punch list. But Ron and I have been monitoring that, and so has Darren Biggs. We haven't seen anything materially. They have kind of pressured us to make a solution, or decision, on turning on the signal heads. Those are the new signals that they installed. So, I have my traffic engineer looking at those test reports that they provided us. I suspect that the signal heads are going to show that they're working and they can be turned on soon. I'm not a traffic engineer. You know me to be a water/wastewater engineer. So, I'm going to lean on my traffic engineer to say yes or no to that. So, I suspect we'll get a decision over to Ron very soon here to allow those to turn on.

Now, as to the other infrastructure, the roadway, the relocated roadway and the culverts along it. No, I'm not comfortable with how things are going out there. I've seen smaller contractors on smaller jobs get some of these projects done real quickly so that they can turn that infrastructure over to the municipality and not have to be relegated the responsibilities of maintaining it. So, I really am depending on the staff at TJX to go quicker. We need it to. Otherwise, we're going to be in the fall and this is going to become an issue.

So, did they want us to make a decision whether or not that the Village, as a whole, was comfortable with resurfacing with the same mix or a different mix or what was that whole

discussion?

They haven't said anything about that, Kellie. That's a good

question. From what I understand from speaking with the department heads and yourself, the decision is to resurface the road. And I've given a means to do that in the last memo that I sent out. Everybody should have received that. So, we

are going to require them to resurface the road.

MR. RADTKA: Well, is it your opinion, Chris, they should go with that

different mix?

MR. KOGELNIK: If a contractor is going to use the same contractor—if the

MR. KOGELNIK:

prime contractor is going to use the same subcontractor to pave that road, and that subcontractor has told me we're going to get the same result, I'm not going to go with the same thing. I'm going to tell them to utilize a product that I know is going to have a tight surface, and we're going to go with that. I'm not going to get wrapped up into that. I'm not going to say that the contractor did something very wrong on the first pass that he made with the resurfacing. We weren't there full time to monitor that. I would suggest the next time we do this resurfacing we do have somebody there full time to monitor this because it is a much different road than you had when it was a straight through shot.

If you want, maybe you can assign that to the Road Department or to us, and we'll be out there to monitor this. But I do recommend we use a different product if

they're going to go with the same subcontractor.

And we have no indication whether they are going to go with MS. BORDNER:

the same subcontractor or not, correct?

MR. KOGELNIK: Right. And we can't make them go with a different

subcontractor.

MS. BORDNER: Correct.

MR. KOGELNIK: We can tell them we're not comfortable with that

subcontractor. But, you know, that's where we're at right

MR. BLANK: Chris, do you know if the contractor has been paid much

pretty most of his money?

By TJX? No. I don't know that. MR. KOGELNIK:

MR. BLANK: Because if he has-

MS. BORDNER: I think that's going to be part of the issue because I think that

the contractor is going to look to the subcontractor for the

first time around and where that liability may lay.

Do we have any way to assure that this doesn't just drag on MR. BOND:

pretty much indefinitely?

MR. KOGELNIK: That's not a question for me I don't think. I'd like to be able

to answer you and help you out, but I can't.

MAYOR HILL: I'll make a couple phone calls.

All I can do is tell you what technically is apparently wrong MR. KOGELNIK:

with the work product.

MS. BORDNER: I can offer that I did speak with Mr. Cavicchi, Mark

Cavicchi, from TJX. He's aware of the situation and he knows that they can't seek the dedication and acceptance of the roadway until the roadway gets straightened out to a point where it meets Village standards and Mr. Hickox and Mr. Kogelnik feel comfortable signing off on that. So, he's

aware of that.

MR. LIMING: Is he concerned?

MS. BORDNER: I can't say that he is, in my opinion. Based on our

> conversation, he felt that it would run its course and it would take its time and they would get to it. But I explained that the roadway can't be opened up for public use until such time as it has been dedicated and accepted by the Village for

public use and maintenance.

MR. KOGELNIK: The contractor has, as you know, some to—do items along

the road. In order to get those to—do items done, he's going to need to use the road. He should be getting those to—do items done and saying, "okay, I've gotten that done. Let's get

this addressed about the pavement" because the pavement resurfacing has to come after that. But he's not even doing all of this logical planning that we would normally see from a contractor. That's kind of what's puzzling. This is a very big contractor.

MR. BOND: What's to stop this from still being an ongoing issue a year or

two years down the road?

MR. BLANK: They've got to put pressure on TJX. They hired them.

MR. BOND: Right. MR. KOGELNIK: Yes, that's—

MR. BLANK: People have been asking us when they're going to open the

road. We have no clue.

MR. KOGELNIK: I don't have any answers on that. That's the million dollar

question.

MAYOR HILL: I'll give TJX a call tomorrow and find out once I talk to them

and say, "hey, this is what we're waiting on." I may even pass Chris' number on and say, "let's get this done so we can

get it over with." I'll make the call tomorrow.

MR. LIMING: It's becoming—MR. BLANK: Uh—huh.

MS. BORDNER: Mr. Cavicchi is aware of what it takes to come to Planning

Commission, you know, for dedication and acceptance. He doesn't seem concerned that that's going to be a daunting process for them. And it really is not. So, it shouldn't take long to get them before the Planning Commission to get it

approved once they finish the process.

MR. KOGELNIK: I don't think it's an inordinate amount of work, even with the

resurfacing.

MAYOR HILL: Any other questions for Chris?

(NO RESPONSE FROM COUNCIL.)

MR. KOGELNIK: Thank you.

MAYOR HILL: Special reports. Police Chief Milhoan?

CHIEF MILHOAN: I submitted my monthly report for May. Answer any

questions if you have any.

The only other thing I have, Mayor, is I'd like to commend Kellie Bordner for her work on the zoning situation at the old grocery store on Tod. I have seen an improvement. I'm sure

it's not where it needs to be, but there has been an

improvement. A number of residents have commented to me that they've noticed an improvement. Again, it's probably not where it needs to be yet, but he does seem to be working more now than he's been in the last several months, if not years. I know Kellie has dedicated a lot of time to this, and it's nice to see some improvement. Hopefully, he'll continue.

MAYOR HILL: Getting in their wallet, as Kellie did, it's quite a motivator.

CHIEF MILHOAN: It is.
MAYOR HILL: Fire Chief Eastham?

Planning and Zoning Administrator and Director of

MS. BORDNER: Thank you, Mayor. We have a Planning Commission

meeting on Monday, June 14 at 6:30. There are three site

plan reviews. The locations are at 5787 Tod, 2626 Salt Springs and 6878 Tod. The meeting is open to the public for attendance. I don't know whether you'll be establishing a Zoom meeting; but if you are, then we will make sure that everyone is aware of that on the website.

MAYOR HILL: It is established, and it's been sent to you and Denise.

Thank you. I will make sure that the participants get that, as MS. BORDNER:

well.

And just to thank you, Brent, for that commendation. I appreciate that. And just to pick up where Brent left off on that, unfortunately, he was not fully cleaned up by the deadline. It was minor, however, I don't know what the judge will decide to do with that. So, I sent the pictures to Mr. Fritz, our prosecuting attorney. He has indicated that he would schedule a sentencing review before the judge and have a decision relegated to a written judgment, and we'll go from there. I do not know whether or not the judge will stay at the \$5,000 fine or whether he will consider what remained after the deadline. And I did take pictures and provided that to them so that they could see what it was at that point. If Mr. Rovnak continues to get it cleaned up, I'll be happy to let them know that before that particular hearing. What the judge decides to do is certainly in his hands at this point.

Parks, Grounds, Buildings, Street Superintendent, Mr. MAYOR HILL:

MR. HICKOX: Thank you, Mayor. First off, so it doesn't get lost in the

> shuffle and everything, Bailey Road also needs some attention on berming and where the new pavement and the old pavement meet, some of the bumps. You know, I don't know—I'm not clear, myself, if that was a separate contract, if it's all one project. But we asked them about the berming and we met them out there about a month ago, Chris?

MR. KOGELNIK: Yeah-

Month and a half. MR. HICKOX: MR. KOGELNIK: Month and a half.

They sent one person out with one dump truck load of MR. HICKOX:

something and did a couple of the turn arounds. But there's drop offs three inches from the pavement to, I guess, the berm, you'd call it, that needs some attention. Someone is going to drop off and slice a tire or worse. Just so it doesn't

get lost in the shuffle.

On to bigger and better things, we've been mowing. Trying to keep up with it. Had a mower go down, but we're back on with both of them and we're going just as fast as we can. We now have a lift in the garage, and it goes up and down and picks up cars and trucks. I sent some pictures to a few of you today. It looks great.

We had all four of our big trucks on the road for the first time in three years. All of them ran and that was another accomplishment we've had in the last couple weeks. I'd like to thank Tom Dietz and the Scouts and everyone else for the hard work they did to help us have the Memorial Day festivities. I thought it went great.

I was contacted by a lady named Charlene Banks, who says she is the oldest daughter of a gentleman named Arman Bailey. They own 3.75 acres on Hewitt Gifford Road that abuts up to the cemetery. And they didn't know if we had any interest in purchasing that. I told her I'd pass it on to Council, and I have done that.

We began work on baseball field number one. While it was dry, we could get all the dirt hauled in and we're working on that. It's a work in progress, and we're learning as we go. The air conditioner on this level of this building gave out last Thursday. We've got quotes. We've got it ordered. It is in stock. Western Reserve has it in their possession. They're waiting to line up a crane to get it put on. So, hopefully that will be taken care of this week.

On to the auction gov business. If there is no objection from Council, I know there are three large generators that are being considered to be put in this auction. They are very good generators. There's nothing wrong with them. I'm not a doomsday predictor, but with the recent malware and ransomware on the Colonial Pipeline and the meat supply, I fear there could be a problem with our power grid coming. I hope I'm wrong. The generators aren't costing us anything. Sit there, let's let this play out and see if we need to hold on to them if we need them.

Another reason for holding on to them, the generators that we have, backups in all the buildings, are natural gas. So, if the natural gas grid would get hacked, we have diesel generators that we could put in place, and we have a tank of diesel fuel that will run us for a certain amount of time. How long? Who knows. I don't know what's coming, but it would be foolish for us to get rid of them and then need them.

MR. BLANK: Ron, those things haven't been started for years. If you feel

that way and Council agrees, somebody ought to be testing

them and get them running.

MR. HICKOX: If they agree—

MR. BLANK: Because they haven't been started—

MR. HICKOX: —I would get them moved inside first and I would have the

mechanic-

MR. BLANK: You go to use them and they don't run—that's a good chance

that's going to happen.

MR.LIMING: Where did they come from?

MAYOR HILL: Pump stations and the sewer. When they upgraded the sewer

pump stations, we put in bigger pumps and these were taken

out and just set over there.

MR. BLANK: And then Council and BPA went halfers on the other one,

which was close to a thousand dollars.

MR. HICKOX: I believe they're 10 to 15 KW. Large enough to do some

good, to definitely—it would power this building for

whatever we would need it.

That's all I had. It was a busy couple weeks.

My opinion, I think he should have the mechanics go take a MAYOR HILL:

If we do keep them, generators should be exercised every so MR. BOND:

MAYOR HILL: Absolutely. And they should be stored inside. If they work and there is interest in keeping them, a MR. BOND:

schedule ought to be set up for exercise.

> here now monthly. Running them for an hour or so to keep them dried out and make sure they're going. We've been

doing that since February.
