Commission and we looked at that berm for Fear Forest, and we found that it was obviously not at eight foot height. So, I gave Kellie the information. She can take it from there. Also, we started doing the plan review for the second phase

of M&M's site plan. And, so, we've gotten some information. It's piecemeal manner, of course. We're

commenting on it as much as we can on that.

With Ultium's project, I talked with Bill Blank before the Council meeting and what we need to do is we need to get under contract with the tank through CB&I, but we're

waiting on GM. It's my understanding, from talking with Bill, to give him the response they need for the funding. So, that's what we have going on. Is there any other questions

Council might have?

MAYOR HILL: Anybody have a question for Chris?

Chris, what was the deadline on that? The 29th of June? MR. BLANK:

I believe it is, yeah. MR. KOGELNIK:

> Two more things I want to mention. We do have a memo that we produced for the Ellsworth Bailey Road signals that were installed by TJX, and I'm going to distribute that. I talked with Ron before the meeting got started. So, I shared that memo with Kellie and a few of the Council and with Ron. It sounds like there's a general consensus to move forward on that. And, so, with that, we're asking for TJX to have their design consultant that designed the signals come out and take a look at the signals just as a cursory review. Because all we did was look at the equipment versus what was on the plan. And we compared that to make sure that what was designed was in the field. And so that's good. But we do request the design consultant to come in and take a look at this. And the reason is because we weren't privy to the approval processes for those signals that MS may have went through with ODOT or any other regulatory agency there. So, we've done our part there. From our part, it looks like the signals can be energized. So that's a good first step. But TJX has a number of other punch-list items that they need to address on Hallock Young Road, the relocated part. And then, also, with Ultium, Darren and I have done a couple days' worth of testing out in the field or monitoring of the testing of the sanitary sewers. The meter manhole started up fine. They have backup power supply they're installing.

Secondly, I've reviewed all the internal televising reports. That's the internal videography of the sanity sewers. It's boring, as you can imagine, but somebody's got to look at it. And what I found is there's some issues there. I wrote a memo and we're going to distribute it, but they've got some homework on their part at Ultium to clean up those sanitary sewers. That's all I have to report.

MAYOR HILL: Council have a problem if the Solicitor makes a comment?

MR. RADTKA: No problem at all.

SOLICITOR DUTTON: For those of you in the audience and constituents in the

Village of Lordstown, you probably believe, as one would normally believe, that every employee here is an employee of the Village, which you are, and your compensation comes from the General Fund. That is not the case. We have an enterprise activity in which we operate utilities here. The employees of that utility department come under the

jurisdiction of the Board of Public Affairs. And the Board of Public Affairs adopts a budget based upon its income from the sale of the water and sewage services. And as long as they are within that budget—in other words, think of your

budget at home. You have so much revenue and you have so many expenditures. They have to expend that money any way they want. If they're borrowing money from the Village—in other words, they're losing money, they're in the red and they have to borrow money from the General Fund, from Village Council, in order to balance their budget, then those expenditures must be approved by Council. And we've gone through maybe ten years of that since I've been here. Well, recently, they paid off their debt to the Village. I think it was a \$50,000 obligation. So, the Board of Public Affairs has a right to increase wages of its employees as long as it's within their budget.

This Council is probably wise to ask the Board of Public Affairs for a copy of the budget and the revised budget because they're going to have to revise their budget to accommodate the increased wages for the balance of the year and going into next year to see if it makes sense. But, other than that, this Council has no right to object to it. Now, several Council members have asked me personally "can I vote no on this?" Yeah, you can vote no, but there's one payroll department. It's run out of Mr. Blank's office. And for payroll purposes, you have to have an Ordinance that authorizes his office to issue paychecks. So, the answer is, yes, you can as long as a majority of Council votes yes. Otherwise, the BPA can ask the court for a mandamus. A mandamus is an order mandating Council to authorize the creation of a payroll. And if you have lived in this community long enough—this has happened in Warren, happened in the City of Youngstown with parks and grounds -they have a separate parks division. It's a separate enterprise. But I didn't want this to go with the idea that this Council is immune or ignorant of the fact that this is a controversial issue.

Now, the other departments, police, fire, parks, buildings, grounds, the planning and zoning commission. They all derive their compensation from the General Fund because those tax revenues aren't the proceeds from the sale of water and sewer. You don't commingle them. And, in fact, you don't commingle water and sewer. You could be making money in the water department, which I think they are, and losing money in the sewer department. So, you might, you know, take that into consideration. I'll be glad to answer anyone's questions. But I thought that was important for the record.

MS. FREE: I do have a question. If we—

MAYOR HILL: Identify yourself.

MS. FREE: Veronica Free, Parks Department. I just have a question like if it's separated like that and one department needs our help,

do we get their wages, too, when we go to help them?

Because that happens often.

SOLICITOR DUTTON: No. Unless it's in the Ordinance—in other words, unless it's in your pay Ordinance that if you're performing work as a

member of the BPA that you would then receive those wages. And probably what would make more sense is that you would continue to get the portion of wages from the General Fund that all other employees are, and you would

get the surcharge that would be billed to the BPA—

MS. FREE: Because I know they have a different pay—

SOLICITOR DUTTON: But that's not in our Ordinance to my knowledge—

MS. FREE: —but can we document that if we're helping them, or not?

SOLICITOR DUTTON: This is a complicated issue for this Village—

MS. FREE: Thank you.

SOLICITOR DUTTON: —and your question is well taken. But I did want you to

understand and know that.

MR. RADTKA: Also, to answer your statement, I did get ahold of BPA

president, Mr. Campbell, and requested the amended budget stuff. They said they would work on it and get it to us. That

was after our last meeting.
