did get the cameras installed that CSX donated the money for. We do have some tweaking. We have some things and

some ideas so we can see a little bit better to the crossings. But, for the most part, they are up and

going. One of the things we're waiting on is the monitors. They got hit by lightening. Hudson Communications sent back—I think they're going to get them covered under

warranty. So, that's done.

The GovDeals, as of today, they deposited \$509.99. We have about another \$500 outstanding that's been paid that GovDeals will deposit within the next week or two. So, we

have about \$1,000 in things we've sold out of there. And we did pass a Resolution on the two FEMA grants earlier this year that we wrote. With the help of Kellie Bordner—she did all my narratives, and I did all of the researching. We were successful. We did get one of the two grants so far. The other one we're still in the running for. I want to thank Kellie. She did a lot of very, very good narrative work on her part. We did receive \$97,190.48. Our local share is \$4,859.52. So, almost \$5,000 for \$100,000, roughly. These are for rescue tools to replace our dual lines on our jaws, spreaders and rams that they no longer

service. And, also, new MARCS pagers to get us off of the VHF pagers that are roughly about 18 years old. So, those are the two items that will be purchased with that—well, multiple items, but those two things. That's about it.

But, like I said, I really wanted to thank Kellie. She put in a lot of very good narrative work. All I did was all the data and research. I explained it. She wrote it. It worked out very

well.
