a half years.

One of the big things which Lordstown Motors has had a problem with is getting funding and here's this company that has some pretty deep pockets. So, hopefully this project can be moving forward and funding will not be the top issue, which they need. I haven't been notified. I am waiting to, you know, hear what's going on. But, hopefully, within the next couple weeks I'll get a call and I'll get an update and see

what's going on, and I'll report back to Council.

And, I believe, Mr. Radtka will be calling for two executive sessions this evening. That's it for the Mayor's report.

CHIEF MILHOAN: Mr. Mayor, I was under the impression that we were going to

have further discussions tonight reference to the K9. Was I

mistaken?

MR. BOND: I haven't heard anything about it.

CHIEF MILHOAN: The last Safety meeting we had we talked about taking it

before Council as a whole to discuss fundraising. And I thought we were going to discuss it tonight. We've been approached by individuals wishing to donate, but, obviously, we can't do that yet without the pleasure of Council. I was under the impression we were going to talk about it tonight.

MAYOR HILL: Bob, that's your committee.

MR. BOND: Okay. I wasn't present at the last Council meeting. I thought,

Don, you told Council about that at that meeting.

MR. REIDER: I did explain that, did I not, Chief? At our last Safety

meeting it was recommended by, I think, Officer Blank and you that you were going to move that forward to the year 2023 to apply for a K9. I think that's what was discussed;

am I correct?

CHIEF MILHOAN: Yeah, but we also discussed fundraising now to see if we

could raise the money to move forward.

MR. REIDER: I didn't—MR. BOND: Okay.

MR. REIDER: —I don't see a problem setting a meeting up so they can do

it.

MR. BOND: I don't either.

CHIEF MILHOAN: Setting a meeting up?

(SEVERAL MEMBERS TALKING)

MR. SHEELY: He wants everybody's blessing, right?

CHIEF MILHOAN: Correct, yeah.

MR. BLANK: You already had a meeting.

MAYOR HILL: Basically, you're asking Council's pleasure to see if they

would approve you in case someone approached you about funding for a police dog, whether they would back you on

that?

CHIEF MILHOAN: I just want to know if we're allowed to start raising

money. Because we've been approached by people who are willing to donate, but I didn't think it was appropriate to start accepting donations without having Council's blessing. Because I thought what came out of our Safety Committee

was it was going to go before Council as a whole.

MR. BOND: We had talked about it, and I thought—I was not at the last

Council meeting. I really haven't had a chance to talk to Don that much about it. I thought it was somewhat discussed at that time. Apparently, it wasn't. What mechanism are you going to use to handle this money? Is it going through the Clerk's office? Is it going to be handled by the Police

Department?

CHIEF MILHOAN: When we talked about it at our Safety meeting, we talked

about running it through the Lordstown Police Association.

MR. BOND: Okay. The Association?

CHIEF MILHOAN: Right.

MR. REIDER: On a pledge basis; am I right?

CHIEF MILHOAN: Well, we talked about that, but as we talked about in our

Safety meeting, the downside of accepting a pledge from somebody and not actually accepting the money is I don't know how long this endeavor would take. And, if we take a good amount of time and we go back to the individual that said they would donate, and they've fallen under hard times or something has changed financially with them, they may not be able to give at that time. So, I'm open for discussion, but I see the pros and cons of both. And I don't want to speak for Clerk Blank, but I don't think Bill felt comfortable

running it through the Clerk's office at this time.

MR. BOND: I don't think he would either.

CHIEF MILHOAN: We talked about it in Safety Committee about running it

through the Lordstown Police Association, keeping a ledger, as we do with our Shop-With-A-Cop Program and our food

drive. We discussed this.

MR. BOND: This would be put into an escrow account, or what? There's

been no discussion on that, that I recall.

CHIEF MILHOAN: We have an account at the Credit Union, just like we do for

Shop-With-A-Cop-

MR. BOND: Okay.

CHIEF MILHOAN: —and our food drive—

MR. BOND: It will be a separate account? How are you—

CHIEF MILHOAN: A separate account.
MR. LIMING: You'd have a K9 account.

CHIEF MILHOAN: That's correct.

MR. LIMING: Period.

CHIEF MILHOAN: That's correct.

MR. LIMING: And you're going to know who is putting the money in so if

something-

CHIEF MILHOAN: We receipt all the donations.

MR. LIMING: —goes and it doesn't happen, you could give the money

back; am I correct?

CHIEF MILHOAN: That's correct.

MR. LIMING: I have no problem with that.

MR. BOND: I don't either.

MAYOR HILL: I believe the Solicitor might like to make a comment on that

if Council doesn't mind.

SOLICITOR DUTTON: Right now, the money that you're collecting is aspirational.

In other words, these are people who would like to have a K9

patrol officer-

CHIEF MILHOAN: I would assume.

SOLICITOR DUTTON: —and they're willing to fund it?

CHIEF MILHOAN: Yeah.

SOLICITOR DUTTON: Okay. And, once 2023 comes around, and you have enough

money, you don't have enough money, but let's assume Council authorizes you to purchase this dog. Then you need to formalize this in an Ordinance because this is a service.

CHIEF MILHOAN: Sure.

SOLICITOR DUTTON: It's a service. It will be a drug dog, but it will also do other

things. And you can't fund a service on donations. In other words, it's like running a Police Department on donations. This is a service. So, you're going to have to create a subfund within the police budget. At the beginning of the year, if you authorize this, there has to be an amount of money that will fund this for the food, the medical care for this dog and anything else that has to go. If you don't have enough donations, Council is going to have to appropriate the shortfall. And that would run for one year. Then the next year, it would have to be included in the budget. But, it has

to be run through the Clerk's office—

CHIEF MILHOAN: Sure.

SOLICITOR DUTTON: —if this is a Village service. And this is not a one-off. In

other words, Council appropriates money for the Apple Cider Festival for fireworks or something, and those are oneoff events. This is a continuing service. That's why it has to

be in the budget.

CHIEF MILHOAN: Sure.

MAYOR HILL: You don't have—take a poll. Lamar, you said you have no

problems?

MR. LIMING: I'm fine.
MAYOR HILL: Howard?
MR. SHEELY: I'm fine.
MAYOR HILL: Bob?

MR. BOND: I'm fine with it.
MR. REIDER: That's fine.
MR. RADTKA: I'm fine.

MAYOR HILL: Looks like you have the approval here to do that, Brent.

CHIEF MILHOAN: Okay. I believe at the last Safety meeting we also talked

about amending the seat belt ordinance. My understanding was that was going to go before Council as whole, as well. So, I'm just looking for—I don't know if this is the right time to discuss this, but that was my impression, that we were going to talk about it as Council as a whole. The Safety Committee wanted to move it before Council.

MAYOR HILL: I wasn't at that meeting, so that's why I'm not aware of it.

MR. BOND: As people in the audience may not know exactly what we're

talking about here, this is to move it to a primary offense instead of a secondary. Meaning, you could be ticketed just for the seat belt. Before you had to be, like, speeding or something of that nature. I, personally—there's only a couple places doing it. There's no case law on it. I'm pretty leery of it, myself. And I don't really think it would be a good idea at this point to do that, but everybody's got their

opinions.

MAYOR HILL: Any comments from Council on this?

MR. REIDER: Yes, Mr. Mayor. I didn't think we were going to discuss this.

I've been doing some checking and everything and I read the opinion. I read the Ordinance the way—I think you had contacted our Solicitor to have it rewritten with the way you

want it-

CHIEF MILHOAN: Correct.

MR. REIDER: —and I think there's some serious concerns with it. I don't

particularly care for it because, you know, under this Ordinance, the way that it's going to be written, that you can—and some of them are highlighted. They're all here. And I don't know if all of Council ever got a copy of the whole thing, which they didn't. So that's why I wish we could get a copy of them and maybe discuss this if you can

hold off-

CHIEF MILHOAN: Sure.

MR. REIDER: —until the next Council meeting. And I will give them each

a copy—

CHIEF MILHOAN: We don't have to discuss it now. I just thought that was the

route that the Safety Committee was going. We didn't get an answer out of Safety and I thought they were going to take it

before Council.

MR. REIDER: I want to give a copy of this. I did some background

checking and everything. I'll make sure each Council member gets a copy of it and then probably—and I don't want to speak for the chairman—probably the next Council meeting we can discuss it if you choose. There's a lot of questions here and I want them to see what this entails. I did a lot of checking from your reports, and I don't know what the real reason is if you change it about the seat belts. We went through the whole year of 2020. We wrote a total of 665 citations, what I read off of your reports. And then up and to August of this year, another 399. So it makes a total of 1,064. And we issued 24 seat belt tickets in all of those, over a thousand citations.

So, I want to give it to everybody so they can sit back and read it. I think we should probably have an answer for you

next Council meeting.

CHIEF MILHOAN: Well, that's fine. I'm not in a hurry. We discussed it in the

Safety meeting as far as the reason that we were wanting to do this. Just so all of Council knows, the thought behind it was it would give our officers the ability to stop somebody that's not wearing their seat belt if they could plainly see that they were not wearing it. The goal here—contrary to what I've heard—the goal here is not to have our officers go out and write a bunch of seat belt tickets. I, one hundred percent believe, that you're not going to see a drastic increase in our

seat belt citations that we issue. The idea behind this was to give our officers a tool to stop a vehicle, which many times, leads to other things, such as drivers driving with suspended licenses, warrants, drugs, things like that. It was nothing more than a tool. It was not to generate more income through fines. I'm certain that you're not going to see a big increase in seat belt writing.

But, if you're not comfortable with this, I respect that. It's just something that we were trying to give our officers the ability—I mean, to be honest with you, and I think anybody can understand this—there's many times that we can't tell if somebody has their seat belt on. If you're traveling one direction and they're traveling the other, and their windows are up, you really can't tell. But there are times when an officer could be sitting stationary on the road or close to an intersection and he or she could observe somebody not wearing their seat belt. It's just another opportunity for an officer to make contact with that individual. Not to write them a ticket, but to encourage them to wear their seat belts. But, again, it's to allow that officer a tool to that could lead to other things. So, that was the reasoning behind it.

I understand that, Chief, and I appreciate that. I'm somewhat surprised the state is staying with where they're at and this has been confined to a very few municipalities. I think there was some talk even from their Solicitor that there was no case law that exists on this or whether it was proper, like, if you made a drug arrest from this and stuff. And I thought we were just leaving some more time for this to shake out to make sure where we're headed.

Everybody should wear a seat belt when they're driving. I don't think there's any—that's settled to science. I don't think there's anyone ridiculing that. Do you see anything else on it, Don?

Well, the only other thing I see is the—

I don't have the report in front of me right now.

I want to give a copy of this to every Council member.

Yes.

They can read it. We have these two communities in the whole State of Ohio, you know, wanted to sort of change their thinking like you do, that was Orange Village and Pepper Pike. I'm thinking of all the municipalities. We have 88 counties. I'm sure we have thousands of communities. And no one has ever wanted to change this since that seat belt law has been in effect, nobody. All of a sudden now and even their law directors have questions about it. Because when you're going up against the state—if a gentleman gets pulled over or an individual gets pulled over and, you know, they find something else in the vehicle, there's a chance that could get thrown out of court because they charged them with the wrong thing. But, anyway, I want to be able to do that. I want to give a copy to each one of them, let them read it for a week or two, and then the next Council meeting we'll bring it up, let us

know how everybody feels.

MR. BOND: This is kind of a fundamental change on that particular

aspect of it.

CHIEF MILHOAN: I suggest maybe contacting Orange Village. I did. When I

spoke to the chief up there, he indicated to me that a number of communities around him have done it, as well. I don't have a number for you. I'm not going to say there's 15 or 20. I'm not going to say there's five. He just told me that he was one of the first communities that did it. I asked him, "did you have any problems from it?" He said, "a number of communities around us have done the same thing." I don't know what that means as far as—I didn't ask him who they were or how many. He did mention Pepper Pike. I know they're mentioned in the article. I don't know how many

there are.

MR. RADTKA: Has anyone asked the Solicitor to give an opinion? MR. BOND: My question, Paul, would be if the State law doesn't

recognize it as a primary offense, and you stop someone for it as a primary offense and you find contraband or drugs, a person goes to court and says they didn't have probable cause

to stop me-

SOLICITOR DUTTON:

(Laughter.)

MR. BOND: No-

SOLICITOR DUTTON: But you're hitting on the argument a defense lawyer would

You sound like a defense lawyer.

make. The Supreme Court would ultimately decide. If you have drugs in the car and you are arrested for a seat belt violation, and then they discover illicit drugs, and then you're charged with that offense, the defense counsel is going to say that you didn't have probable cause because this Ordinance is

unconstitutional, or whatever.

I just mentioned to the Mayor, remember, guys, when you were in high school and you had your muscle car and your girlfriend sat almost on your lap, she's the one who would

get a ticket. She doesn't have the seat belt on.

(Laughter.)

MR. BOND: I don't know if that was in effect—

SOLICITOR DUTTON: They had seat belts back then. It was the—

MR. LIMING: Yeah, but it wasn't the law.

SOLICITOR DUTTON: It wasn't the law, but that's who would get the ticket.

I don't have an opinion on it. I mean, anything that you do to enforce the law is a good thing. People should wear seat belts. And the flip side, they shouldn't be used as a means to

harass people.

I'm just thankful you guys don't have the speed cameras out

because I think that is-

MR. REIDER: We don't want those.

SOLICITOR DUTTON: But, you know, you could call the Ohio Municipal League

and get a count on the number of political subdivisions that have this kind of an Ordinance or a regulation. You might discover that it's more than a handful; you might discover it's

only a handful.

MAYOR HILL: Okay. Brent, you've got a little bit of direction there.

CHIEF MILHOAN: Thank you.

MAYOR HILL: Is there anything else under new business Council would like

to discuss before I ask for public remarks? (NO RESPONSE FROM COUNCIL.)

MR. DIETZ:	Public remarks? Going once. Tom? I'd like to thank the Council for their ongoing cooperation with the Fall Festival. I do believe our fireworks thing has expired this year. So, that's going to have to be brought up again.
