Mayor's report. I want to remind everybody Trick-or-Treat is the 30th from 5 to 7.
And I attended a Meander Dam improvements meeting where they're trying to go for \$41 million to rehabilitate the dam, which is 94 years old. There's three spillways in jeopardy. There's subsidence and there's 220,000 customers served by that dam. So, if something would happen, we'd probably be okay being tied into the City of Warren. They're trying to apply for a 75 percent grant. They did ask when I went to the meeting if I would, you know, the mayors would write a letter of support and also if Council would be willing to do a Resolution in support of them applying for the grants. So, I'll try to get some information for the wording for that,

and I'll get it to Paul and let Council know that it may be coming down the pike.

MR. SULLIVAN: Halloween is a Saturday or a Sunday?

Special reports. Police Chief Milhoan?
CHIEF MILHOAN: Yes, Mr. Mayor. I'd just like to update Council. At the request of Mayor Hill, I applied for a grant through the Ohio Office of Criminal Justice Services for body cameras. The OCJS has allocated \$5 million to be used for body cameras. We've applied for the grant. We got our application in on time.
Our total amount of equipment that our department would need is \$53,700. That includes the body cameras, the redaction equipment and the software, the servers. There's a lot of equipment that goes with this. We do not know when we will find out whether we received the grant or not. I'll keep you updated. I suspect that with the number of agencies in the State of Ohio that has applied, the \$5 million is not going to go very far. I would anticipate that instead of us receiving the full amount, we may get a percent. If that's the case, Council will have to decide whether we want to move forward and accept the grant. There are no matching funds for the grant. My hope is that we get all the money we need for the project, but I suspect that we will not get all of it. So, I'll keep you posted.

We're going to begin another round of roadside mowing. The grass just will not give us a break this year.
The only other thing I have is the county has completed the culvert project on Palmyra Road, and it's open again. I was down there looking at it. It's a very nice job. They did a great job with it.
