Weathersfield Township that has their water. They were afraid that would happen in Lordstown. I explained to them that it shouldn't because we were a Municipal Corporation.

Possibly Paul could briefly comment on that.

SOLICITOR DUTTON: Mr. Bond is correct. We are not—first of all, there's been no

discussion about any annexation with Niles and the Village of Lordstown—but, in terms of pure speculation, legally we are an Ohio Municipal Corporation. We have a Charter form of government. Another Municipal Corporation does not have the right to annex us. Now, Weathersfield Township is an Unincorporated Political Subdivision and if Niles extends utilities into Weathersfield, it's reasonable that that is an issue. Same situation with Howland. There's another annexation issue. Howland is a township. You are correct.

We are not a target for any annexation.

MR. BOND: Thank you, Paul.

have to bring and offer to the Village if they would.

MR. MORRIS: M&M Industries has been in business for well over 30 years.

We have three operations in the United States. Two in Chattanooga, Tennessee, and one in Phoenix, Arizona. We're excited about the opportunity of being able to further our company and grow and be a part of the Lordstown community. We are very pleased with the culture here. We feel that it is a good alignment, closer alignment to what we believe. We look forward to being your neighbors, and we

look forward to you being ours.

MAYOR HILL: Appreciate that, sir. Any other comments?

MR. BOND: Yes, Mr. Mayor. Bond again. I think we'll see possibly more

of this, too, coming due to the plant going into Pittsburgh plastics industry. It should boom in this whole area I would think. With that being said, I am going to be voting against this abatement because I feel that we'd be better served to give lower abatements. I think our main competition in a lot of this is Jackson Township to the south, which gives no abatements. That's the way I feel about it, and my vote will

reflect such. Thank you.
