cruiser. They are seeking matching funds. They did put it out to other businesses in the Village but haven't gotten a

response yet. So. We'll see what happens there.

Solicitor's report?

SOLICITOR DUTTON:

Mr. Mayor, I have no formal report but as I sat down here, my phone buzzed. My son, who is a lawyer out in California —go figure, San Francisco—he forwarded me an article that was just published in *Bloomberg Business Week*, which says, "Lordstown Auto Industry is Coming Back." So, you might

want to look at that.

MAYOR HILL:

There you go. Bloomberg. Everybody mark that one down.

Any questions for Paul?

(NO RESPONSE FROM COUNCIL.)

Treasurer's report?

MR. EBLING:

No report.

MAYOR HILL:

No one is here from the Board of Public Affairs.

Village Engineer's report, Chris?

MR. KOGELNIK:

I have a couple items. The one thing that I have been coordinating with Ron about is we're working with Ultium's engineers. As you might know, they are planning a new signal for the Ultium driveway on State Route 45. We're helping them to scope out that work appropriately in regard to what the Village's responsibilities are, review it and give them comments so that they can be on their way to completing that design. So, we're working with them on that.

Last week I was called out to the relocated section of Hallock Young Road by Darren Biggs from the Water and Sewer Department. There was a break or something that happened with the sanitary sewer carrying the waste from TJX's site into the Trumbull County system. There was a surcharge of that wastewater. It then went into the roadside swale and then traveled down into the stream there. So, Ohio EPA was calling me several times today to figure out what happened. After talking with the county officials who responded to it ultimately and then made some sort of corrective action out there last Wednesday. I told the Ohio EPA what I knew and that they should contact the county, and they did. So, I wanted you to know that I have received some calls from Ohio EPA about that. That's all I have.

Does anybody have any questions?

Ouestions for Chris?

(NO RESPONSE FROM COUNCIL.)

Thank you.

Special reports. Police Chief Milhoan?

Yes, Mr. Mayor. Earlier this afternoon I emailed the Safety Committee, and I cc'd the Mayor and the rest of the members of Council to update all of you on the status of our outdoor weather sirens. Dan Bodette from Federal Field Services recently came to the Village and inspected all ten of the sirens and made the appropriate repairs. Of the ten sirens that we currently have, four of them were not working, which, obviously, I'm sure that's concerning to all of us. We were aware that one of them wasn't working, possibly two. But we found out that four of them were not working. Of the four that were not working, three of them had blown fuses, and the one over on Hallock Young near Lyntz, which was spinning continually, that was caused by a wire that was pinched inside the cabinet and grounded out the wiring and opened the relay up and it caused the siren to continue to spin.

Back in the third week of October we had a tornado warning come through our area, and we set off our sirens. But, obviously, only 60 percent of the sirens were working at that time. I bring that up because just to let you know where we're at. They are currently all working now, all ten of them. But it may be something that Council wants to consider having some type of a service agreement on these. They are not under warranty anymore. So, whether you go with somebody like Federal Field Services or Jake from Hudson Communication or whoever, it might be something that we want to consider because we really don't know—I mean, we test them every Saturday at noon. But if

we're not there, if we don't have an employee at all ten locations to see if they're working, or if a resident doesn't call us and tell us that they're not working, we really don't know. And really of the four that weren't working, three of them were fuses. The fuses were five dollars. So, I mean, it's a minimal cost to get the parts, but I think if we're going to have these, we might want to take a look at servicing them on a regular maintenance basis.

Dan did recommend that the siren on Highland Avenue, south of Salt Springs, north of Hallock Young, by the tracks there, there's a pine tree that he recommended that branches be cut back from the siren. I've already gotten a response from the Street Commissioner, Ron Hickox, and he will look into taking care of that.

So, I just wanted to update you on our siren situation.

I guess the only one I got, do we know where that fuse is

bad? Didn't we have any?

CHIEF MILHOAN: MAYOR HILL:

I don't know. It's in the box somewhere, but I don't know. I don't know if that would be something where our guys could just go take a look at that or not. I'm just throwing it out there because a five-dollar fuse, it might be something where we may want to look at it to avoid a call. Any other guestions?

We're wrapping up our last round of roadside mowing.
We're going to pour monument foundations this week in the

cemetery.

Our snow and ice equipment is ready to roll if need be. Flags have been taken down along the roadside and put away for the Winter. And they'll be put back up before Memorial Day next year.

Last, CSX will be repairing two crossings and closing Muth Road November 29th through December 1. And Lyntz Road December 1st through December 3rd. And I've let the Board of Education know and sent everyone an email on it. So, that's all I have.

And, if improvements need to be made to the road, that's a whole other story. So, it would be basically recommendations. And the cost of which, Ron, I would say \$5,000. I really can't put a price to that right now because it's—we're trying to manage the

expectations of the Village while also understanding that we have an entity we're dealing with that hasn't fulfilled the

obligations. So, that's all I can say right now.

So, not to exceed \$5,000. So, Council have any questions? Why can't we get TJX to pay—

is they're done.
