- 1. Permission to advertise projects:
  - a. Lordstown, Ohio S.R. 45 Corridor Improvements Waterline Improvements Phase 1
  - b. Lordstown, Ohio S.R. 45 Corridor Improvements Elevated Water Tank 1, Phase 4
  - c. Lordstown, Ohio S.R. Corridor Improvements Site Improvements Phase 1
  - d. Lordstown, Ohio S.R. 45 Corridor Improvements Water Booster Pumping Station, Phase 3

MS. SLUSARCZYK: I don't know. This agreement before you is already signed by Thomas Gallagher on 11/24.

MAYOR HILL: Dutton's approved it.

MR. SULLIVAN: You're good with that staying in there?

MAYOR HILL: It's not more than 60 cents. Yeah, I don't have any problem with that.

MR. SULLIVAN: Okay.

MR. CAMPBELL: All right. Any other comments or discussion? If not, I think Tom had a motion to accept that. We need a second.

MAYOR HILL: I think his motion was to pass on to Council. But he has to make a motion to pass it first, and then it will automatically go to Council.
