Mayor's report. Everybody should have had in their box to have a part-time dispatcher, Hailey Armstrong, put on at the

request of the Police Chief. I concur with that.

We're going to have some dialogue later about electric aggregate. I just found out that every year our gas aggregate program in the Village automatically renewed. They'd send us some information. We would sign it. I was in the program. They sent me a letter saying that I had been switched. I called them up and they said that we do not have a gas aggregate program. So they had always automatically renewed us. So we don't know what's going on there. So that will be something else for the Utility Committee to take a look at. I was kind of shocked and they said, well, the Village never renewed. Well, you don't renew unless they give you the information to find out what's going on. That's it

for the Mayor's report.

Is there a Clerk's report?

Mayor, I just wanted to bring up that I had one piece of MR. BLANK:

> legislation on there tonight and it's for a new server. I can't believe it, but we get these every six to seven years—

MAYOR HILL: If you are unmuted, will you please star six and mute. We're

getting a little bit of background noise. Thank you.

We've been having trouble for a while with this and he said MR. BLANK:

we're due for an upgrade. It's a lot of money, but that's part of doing business. I did go back and look and it's like six to seven years every time we have to get one. The last one was

\$15,000, something. This one is \$23,000.

What is not part of this purchase agreement—but needs to be addressed and will be address because all the parties agreed—we need a temporary and a permanent easement. Once the tank is constructed, we're going to need an easement to get in there and construct it. And then afterwards we need a permanent easement for maintenance and repair. The initial easement that we prepared, literally over the weekend, apparently encroaches upon leased property. Rather than having to deal with that issue, they're going to redesign the easement. So, we cannot close on this. The Mayor and the Clerk will sign the

close on this. The Mayor and the Clerk will sign the purchase agreement. I will approve it as per form, but we

can't close until we button up that easement. Is that when we'll pay then?

SOLICITOR DUTTON: Pardon me?

MR. BLANK: Is that when we'll pay for the property at that time?

SOLICITOR DUTTON: Yeah. We won't expend funds until we close, until we get a

deed for that property.

MR. BLANK: Okay
