ORDINANCE NO. 12-2025

**AN ORDINANCE AMENDING AND RESTATING ORDINANCE NO. 6-2025 FOR THE PURCHASE OF AN AMOUNT NOT TO EXCEED 1,200 TONS OF SALT, FROM KUSH CREATIVE OUTDOORS, P. O. BOX 360486, STRONGSVILLE, OHIO 44136, FOR THE 2025 WINTER SEASON AND DECLARING AN EMERGENCY.**

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF LORDSTOWN, COUNTY OF TRUMBULL, STATE OF OHIO:**

**Section I:** That, pursuant to Ordinance No. 6-2025, the Village of Lordstown authorized a purchase not to exceed one thousand (1,000) tons of salt at the price of Eighty-Two and 00/00 Dollars (\$82.00) per ton.

**Section II:** That because of the inclement weather, the Village needs to amend the Ordinance to authorize an amount not to exceed one thousand and two hundred tons (1,200) of salt at the price of Eighty-Two and 00/100 Dollars (\$82.00) per ton in accordance with the attached **Exhibit "A"** (the terms of which are incorporated by reference and made a part of this Ordinance).

**Section III:** That the Council of the Village of Lordstown hereby authorizes and directs the Mayor and Clerk to enter into an amended agreement with Kush Creative Outdoors to provide needed salt for the 2025 winter season at the above-quoted price.


**Section IV:** That payment for said material shall be made from the 201.335.53242 Snow Account of the M & R Fund.

**Section V:** That all other provisions of Ordinance No. 6-2025 not otherwise affected by this amended Ordinance shall remain enforceable in accordance with its terms.

**Section VI:** That this Ordinance is hereby declared to be an emergency measure necessary for the public health, safety and welfare and for the further reason that this Ordinance must be effective by salt purchasing season.

**Section VII:** That the passage of this Ordinance and all deliberations relating to the passage of this Ordinance were held in open meetings in accordance with the provisions of Ohio Revised Code Section 121.22.
