ORDINANCE NO. 34-2025

**AN ORDINANCE ACCEPTING THE BID OF SARCHIONE CHEVROLET, INC.,  
1572 STATE ROUTE 44, RANDOLPH, OHIO 44265, FOR THE PURCHASE OF  
ONE NEW 2024 CHEVROLET SILVERADO, SUCH BID BEING THE MOST  
RESPONSIVE, LOWEST AND BEST BID AND DECLARING AN EMERGENCY.**

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF  
LORDSTOWN, COUNTY OF TRUMBULL, STATE OF OHIO:**

**Section I:** That the bid of Sarchione Chevrolet, Inc. (a copy of which is attached hereto as **Exhibit "A"**, the terms of which are incorporated by reference and made a part of this Ordinance) for the purchase of one new 2024 Chevrolet Silverado at a net sum not to exceed One Hundred Five Thousand Nine Hundred Forty-Seven and 50/100 Dollars (\$105,947.50) is hereby declared to be the most responsive, lowest and best bid and the same is hereby accepted.



**Section II:** That the Mayor and Clerk are hereby authorized and directed to enter into a contract with Sarchione Chevrolet, Inc. for the purchase of one new 2024 Chevrolet Silverado at a net sum not to exceed One Hundred Five Thousand Nine Hundred Forty-Seven and 50/100 Dollars (\$105,947.50), as indicated in the bid, **Exhibit "A"**.

**Section III:** That payment for said motor vehicle shall not exceed One Hundred Five Thousand Nine Hundred Forty-Seven and 50/100 Dollars (\$105,947.50) which sum shall be paid from the 303.330.55000 Capital Account.

**Section IV:** That this Ordinance is hereby declared to be an emergency measure necessary for the public health, safety and welfare and for further reason that this Ordinance must be implemented to secure the vehicle purchase in a timely manner.

**Section V:** That the passage of this Ordinance and all deliberations relating to the passage of this Ordinance were held in open meetings in accordance with the provisions of Ohio Revised Code Section 121.22.


