Yes, Mr. Mayor. I just have a couple things. I got the chance to go with Mr. Kogelnik and Darren to Ultium the other day. They're still looking into their issues. I know Chris and Darren are still working with Ultium to try to work through the issues. So, I'm sure Chris will have more in his report.

The Antonine Sisters and the Lipkey line, just to give you guys an update, I've been in touch with Councilman Reider. We're going to reach out to them, see exactly what their expansion proposals are. We're still not finding anything on the line. The year on the hydrant is 1995. So I know Cindy looked through the minutes. She's still not able to find anything. We're still working on that.

The new tank has been lifted. I don't know if everybody saw that or not.

And our next meeting is on December 20th at 4:00 p.m.

Thank you. Any questions for Chris? (NO RESPONSE FROM COUNCIL.)

Village Engineer's report?

Thank you, Mayor. As Mr. Peterson pointed out, we did go to Ultium. Mainly we were looking at how the water pumps that they have are operating because we're still sensing out of the water distribution system significant pressure waves, to the tune of 10 psi all the way up to almost 100 psi within a few seconds. So, there's no water system that's going to be able to withstand that over time.

We saw some things that they definitely have to change on their side of the pumps. We were told that their variable frequency drives—those are the motor starters that can ramp up or ramp down the flow pace—were operating with a ramp up of 40 seconds and a slowdown of, I think, around 30 or 40 or something like that. It ended up they were like four seconds. So that's going to still produce wave action and pressure situations out in the distribution system. They need to adjust that. I told that to them right then and there. And then after that, we want to go out and we want to have a few people at strategic locations at the distribution system so that we can monitor with radio and tell each other what the pressures are after we make a few adjustments. So, we definitely are doing more work and evaluating this situation. But right now, the long and short of this story is Ultium is trying to bring in a boat load of water real quick. And at times that can change in a heartbeat. Without the benefit of that three million gallons in the sky of water that we're going to get from the new water tank, we don't have a buffer. So, the water booster station is doing all the legwork right now to provide Ultium the water they need and also meet the demands of the Village. So that's why this is so important and critical.

There were times when we were standing there, we could see in the suction side, the side where the Village is providing the water to Ultium, it had dipped down to a negative pressure. That can't be. That means that it's almost

emptying that pipe of the supply coming into Ultium. That's

how fast they're demanding water. So, during those

situations, their pumps turn off. They have to because there's

nothing in the pipe to draw from. So that tells you the amount and magnitude that Ultium needs water. That's why—that's why you have a three-million-gallon tank. I

want you to know that.

So that's all that I have to report on tonight. I don't have anything else that's on my agenda. Do you have any

MAYOR HILL: The 2nd is Monday. MR. BLANK: Okay. Let's do Tuesday.

MAYOR HILL: Who is going to bring me my birthday cake?

(Laughter.)

MAYOR HILL: The 2nd is on Monday—

MR. BLANK: Let's do Tuesday. I got a lot of work to do in a short amount

of time.

MAYOR HILL: That will give you an extra day to get the budget and all that

stuff

SOLICITOR DUTTON: Is it going to be before the Council meeting?

MR. BLANK: It will have to be after because we don't know how long it

will take.

MAYOR HILL: Also, what date does Council want to set for the last meeting

of the year? The 30th is a Friday; the 29th is a Thursday. This will be a wrap-up meeting like we have every year.

MR. RADTKA: When would you be ready, Bill?

MR. BLANK: I'd like to go with the 30th because I don't get all my figures

until the 26th. That gives me a couple days to get ready.

MAYOR HILL: The 30th?

MR. BLANK: Bob can put it in there.

MAYOR HILL: Bob, if you could put it in—slide it in so we don't have to

pay for it.

MR. COPELAND: December 19th?

MAYOR HILL: Yeah, December 19th. Have the applications by then and

that way Council has 12 days to review them and if they

want to call somebody in-

SOLICITOR DUTTON: Does council know that they have 30 days to appoint a

successor? If you do not do it within 30 days, then the Mayor

has the authority to appoint.

MR. BLANK: Thirty days after December 31st.

SOLICITOR DUTTON: Right.

MR. RADTKA: So we've got until the end of January.

MAYOR HILL: Is there any—yes, Travis? CHIEF EASTHAM: What day was the work session?

MAYOR HILL: It's going to be after the next Council meeting.

CHIEF EASTHAM: After the next Council meeting.
MAYOR HILL: Yes, two weeks from tonight.
MR. RADTKA: That would be the 19th.

MAYOR HILL: So, you've got two weeks to get all your stuff together. CHIEF EASTHAM: Kellie and I were both lost for a second. She asked and I

didn't catch it.

MAYOR HILL: No problem. That will work out good because that way we'll

see what happens. Yes, Terry?

MR. CAMPBELL: I've got one thing I want to bring up. Correct me if I'm

wrong, Howard. Brent has been trying to get—this guy has been calling him about this triple trailer deal. And we have a

meeting scheduled for the 15th at 5:00.

MR. SHEELY: Yes, I believe. The 15th at 5:00.

MS. BORDNER: Kellie, can you make that? If you have to come in an hour

late, can you make that meeting?

MS. BORDNER: I believe so.

MAYOR HILL: I know Kellie has done a lot of the work, but you wouldn't

have a say on that.

MS. BORDNER: I really don't. I mean—

MR. CAMPBELL: If we had a question. That's the only thing I was thinking. I

mean, we already talked about it and I think we're in favor of it. It's just a matter of getting it done. Because Brent's been getting phone calls from this guy with a whole list of dates

here trying to get this done.

MAYOR HILL: Well, that means it will have to be advertised.

MR. SHEELY: When he confirms back with Brent on the day—Brent's

waiting on him to confirm it. So as soon as he gets back,

then I'll deal with those two gentlemen.

MR. BOND: I have a question, too, for Paul. This 24-inch waterline, now

I've talked to Mr. McNinch, he's going to get back in town and we're going to get together for a meeting. Now with this public meeting access act, how does this have to be

handled?

SOLICITOR DUTTON: If a majority of either public body is present, you have to

advertise it and it's subject to the open meetings. You can't go into executive session unless it falls under one of the—and you are actually negotiating, I think, one of the bullet points is if you're negotiating with another public agency. So you, conceivably, if you're negotiating those terms, you could go into executive session. But you are one of three on

the committee?

BOND: **SOLICITOR DUTTON:** So you don't have to advertise it, and you're not subject to the open meetings act, with just three there. How many commissioners are there? Five? Who would advertise that if we had one-MR. BOND: **SOLICITOR DUTTON:** You're not advertising, Lordstown. They would have to advertise to the Sanitary District. And you should hash that out, who's going to attend. Right. I wanted to check to make sure. The way things are MR. BOND: right now. And people like McNinch or Chris, they don't count **SOLICITOR DUTTON:** because they're not-MAYOR HILL: They don't vote. **SOLICITOR DUTTON:** When I say "you don't count," I mean you are not part of that equation. Okay. Thank you. MR. BOND: Anything else under new business? MAYOR HILL: (NO RESPONSE FROM COUNCIL.) I think we got a lot hashed out today. Is there any additional public remarks? (NO RESPONSE.) Hearing none, I'll entertain a motion to adjourn. So moved. MR. CAMPBELL: Second. MR. RADTKA: Moved by Campbell; second by Radtka. Comments? MAYOR HILL: (NO RESPONSE FROM COUNCIL.) All in favor?
