Mayor's report. I do have some Road Department appointments. And, also, Bill has requested some

appointments for the office staff. And, also, Debbie Bracken will be moving to a different position. I'll entertain motions

for those appointments under new business.

That's it for the Mayor's report. Is there a Clerk's report?

MR. BLANK:

No report, Mayor. Solicitor's report?

MAYOR HILL: SOLICITOR DUTTON:

No report.

MAYOR HILL:

Treasurer is not here this evening.

Board of Trustees of Public Affairs report?

MR. PETERSON:

We had our monthly meeting tonight. The only thing of substance is we did send a Resolution to extend water service to Pritchard Ohltown to the Utility Committee.

MAYOR HILL:

Any questions for Chris?

(NO RESPONSE FROM COUNCIL.)

Come on. He just got on. Somebody has to give him a little

bit-

(Laughter.)

MAYOR HILL:

Thank you.

Village Engineer is not here this evening. Special reports. Police Chief Milhoan?

CHIEF MILHOAN:

Yes, Mr. Mayor, Council. As all of you know, we recently advertised for a full-time police officer's position. In fact,

today is the last day for candidates to apply.

I just wanted to update you on where we're at with that. As of right now, I've received 12 applications. If you compare that to the last time we advertised, which was less than year ago, we received three. So, I'm pleased with the number of applications we've received.

I can tell you that a number of them have several full-time years of experience in law enforcement. Some have military. Some have both. Some have college degrees. Some of these individuals have 5, 10, and 15 years experience in law enforcement. So, we're pleased with the applications we received.

I believe that there is a direct correlation between the raises that you guys have given the employees to the number of candidates that applied this time. Because, really, nothing else has changed. On that note, at our last Safety meeting, I had approached my Safety Committee about the possibility of offering some type of lateral transfers. If you're not familiar with that, that means that a candidate could apply to our department that has a number of years experience at another law enforcement agency. And, instead of starting at the lowest pay rate and no vacation, we could raise them up slightly based on their experience that they have at another department. This is something common that law enforcement agencies are offering. I can tell you that I was contacted by three individuals asking me if we offer lateral transfers. And these three individuals decided not to apply.

I think it would continue to make us more competitive. So, my Safety Committee understood the desire to move in that direction, but they requested that I bring this up before Council as a whole. So, I don't know what we would need to do to try to pursue something like this or if you would even be interested in doing this, but I think it puts us in an even better position to attract even more qualified candidates. So, if it means further discussion, we can pursue that; or, if it means not until the contract expires. I'm not sure what your feelings are, but I just wanted to have some dialogue with all of you and get your thoughts on how you feel about that.

What are they looking for, Brent?

Basically, Ron, they're looking for not starting out at the we have four steps in our pay rates. You're either at Step 1, 2, 3, or 4. You climb a step on your anniversary year. So, basically, it takes you about four years to get to the top. The other thing they're looking for that most of these departments are offering in lateral transfers is starting out with some vacation. Right now, regardless of how much

MR. RADTKA: CHIEF MILHOAN:

experience you have with another law enforcement agency, when you start with us, you start with zero vacation and you're given five personal days.

I wouldn't even be opposed to not just me making the decision on what we would offer an employee but maybe involve the Safety Committee and me, and we come up with an agreement and say this individual has five weeks vacation and they're at Step 4 at their place. Well, maybe we start them at Step 2 under the pay and maybe we start them at Step 2 under vacation. I'm not looking to mirror exactly what they're getting, you know, but do that instead of starting them out at the very bottom.

Now, what they do do is they do make them go to the bottom as far as seniority goes. So, for purposes of layoffs and

things like that, they're not going to come in and leapfrog my current employees as far as that goes, as far as shift bidding, those types of things. It really is just giving them some vacation and starting them out at a little higher rate than at the bottom. And it's all based on their experience, you know, what they bring to the table. Their experience, their training, their certifications, their college level, all that stuff comes into play when you're offering somebody a lateral transfer. But, we see it all time. I mean, departments are offering it. It's very common now. I just think it's something that we should at least have some further dialogue on and see if it's something we can come to an agreement on. Mr. Dutton? Brent and I talked about this today, and I advised him that we have rendered an opinion on this previously. And I think it was somewhat in the Parks, Buildings, Grounds, Department, whatever, I think we needed someone to come in and be able to have a CDL license. The question was whether or not that individual could bring their seniority with them for purposes of everything that Brent talked about. The statute says—it distinguishes between a city and a village, both of which are municipal corporations. But a city, which is a public agency that is a municipal corporation which exceeds 5,000 population, is required to accept seniority from another city. But a village or a township is not. So, you're not required, under the law, but if you feel that it is desirable to make you competitive, then you would need to change the wage and benefit Ordinance. We don't have Civil Service here, so you would have a wage and benefit Ordinance and we would create a special provision that would deal with lateral transfers. And you could ascribe to that position as Brent said whatever transfer rights you want. You could limit the number of years to say no more than ten years. Or you could put a cap on the number of vacation days that they would be entitled to or something of this nature. The most contentious would be bidding rights in terms of seniority. If you brought in someone who has 25 years with the City of Warren Police Department and suddenly they're ahead of everybody who has less than 25 years with the Village Police Department, I think you would have a lot of angry people. So, think it through. And it's simple. We would just amend the wage and benefit

SOLICITOR DUTTON:

Ordinance—the master benefit Ordinance.

MR. LIMING: My question is can you limit it just to the Police Department

or does it have to be through the whole Village?

SOLICITOR DUTTON: No, that would be discriminatory.

MR. LIMING: That's what I mean.

MAYOR HILL: We brought a Street Commissioner on, and he got absolutely

no time-

MR. LIMING: Yeah, that's what I mean—

MAYOR HILL: —and he had state time; he had township time; he had city

time. You know and if you do it for one—

MR. LIMING: Change for everyone.

MAYOR HILL: And you know what, I really don't—if it makes us

competitive, it isn't that much I don't think. We'd have to have the Clerk run the numbers or something. But I can't see

doing it for just one department.

MR. LIMING: Well, he says you can't. SOLICITOR DUTTON: You couldn't do that.

MR. BOND: That's something that I know at one time, and I presume still

is, very common in education. When you give a teacher a certain amount of experience, they could transfer, but it wouldn't be very much. I definitely agree you can't use it for bidding rights. That would create a lot of hard feelings. And

that's not the way somebody wants to start a new job.

MAYOR HILL: I agree with Lamar and the Solicitor. You can't just do it for

one group and not do it across the board. You have to have

some equity there.

MR. BOND: That's right.

SOLICITOR DUTTON: And, if you have one guy fall through the cracks, you could

make it retroactive.

MAYOR HILL: Council can decide what they want to do.

MR. BLANK: I'd just like to say—and all due respect and, Brent, I

appreciate what you were saying—but I know when you brought that up before, you had three applicants and you now have 12 and you said how good a lot of them were. And when you gave those raises out, unless you guys all forgot, you are not supposed to touch any contract until 2024. So,

here you go, start opening these contracts up again. I think you would want to hold off until contract time.

MR. BOND: I think you would want to hold off until

MR. RADTKA: That's a good point, Bill.

MR. BLANK: I'm with you, Arno, I think we need to change when

someone gets hired, they have to work one year to get a week's vacation. That needs to be changed. That's too long. It is too long. And if they come with some seniority, I think

MAYOR HILL: It is too long. And if they come with some seniority, I think that we could bump them up a step or two, but that's just

what I feel is fair.

MR. BLANK: That's too long to make them wait.

MAYOR HILL: Now, this would be through the master Ordinance. This

wouldn't be through a regular-

MR. BLANK: Yeah, but we're not going to do one and not the other, so—

MAYOR HILL: Well, everybody would come under the master—

SOLICITOR DUTTON: Not police.

MR. BLANK: No. They have their own.

SOLICITOR DUTTON: But you would do it under the master benefit Ordinance, then

you would do it on the police because that's the only Collective Bargaining. And this is a substantive change in

the conditions of employment that we would have to seek the consent of the union. Presumably, they would go along with

it, but this is a bargaining issue.

MAYOR HILL: Any other questions for Brent?

(NO RESPONSE FROM COUNCIL.)

Fire Chief Eastham?

CHIEF EASTHAM: Yes, Mr. Mayor. I do have a report tonight. We did get all

> of our numbers in throughout the county for fire and EMS runs. Lordstown had a 42 percent increase from last year to this year, which was the second highest in the county percent-wise increase. And we're on a record pace already.

We're on call 55 out of 18 days so far.

MAYOR HILL: Any questions for Travis?

(NO RESPONSE FROM COUNCIL.)

I guess I should have asked if there are any questions for

Brent?

(NO RESPONSE FROM COUNCIL.)

Any idea why there's such a big increase? MR. LIMING: CHIEF EASTHAM:

No. And the thing of it is, we quit running covid probably

right around the first of the year, the first week in January, we ran quite a bit. And it just seems like we're busy. It's not

just us. It's every department around us. Between us,

Newton Falls and Warren Township today, I think we had 11 calls going on at once. It was going from one and back to back to back and every piece of equipment everyone had out and every person they had out. We were just going nonstop for about four hours this morning. So, we had three alone at the same time here. And they were running theirs, also. It

made an exciting morning.

Any other questions for Travis? MAYOR HILL:

(NO RESPONSE FROM COUNCIL.)

Planning and Zoning Administrator and Director of

Economic Development, Kellie?

Yes, Mr. Mayor. I gave everyone some Planning and Zoning MS. BORDNER:

reports for the 2021 calendar year. You'll have in your packets zoning violation fines that were collected; you'll have zoning permits; you'll have certificates of occupancy; and you'll have consolidations and subdivisions that were done last year. All of this, again, was from the 2021

calendar year.

I also had a very productive conversation with Mark Walker of TJX today. He wanted to let us know that he will be getting the subcontractor to physically address the items that were listed in our Village Engineer's memo. He did offer

that this could take a while due to the weather and

manpower, but he is getting on it ASAP and will keep Chris Kogelnik and I updated. He apologized for some internal issues, which prevented these matters from being addressed sooner. But he has assured me that we should see some

movement.

Questions for Kellie? MAYOR HILL:

(NO RESPONSE FROM COUNCIL.)

Parks, Grounds, Buildings, Street Superintendent, Mr.

Thank you, Mayor. I'll echo what Travis said. We had a MR. HICKOX:

busy two weeks yesterday.

(Laughter.)

MR. HICKOX:

I'd like to thank my department for the handling of the storm. We had 100 percent of our employees and trucks on the routes at one time. We had four large trucks, the two one—ton dump trucks and pickup all going at one time. We did the best we could to keep up. When you get two inches an hour of snow, and you start on your route and you have it bare, by the time you get to the end and back, you've got four inches to start over with. So, we did the best we could. Prior to the storm, we were busy rebuilding the Christmas lights to get those ready for next year. We were mowing ditches with our excavator mower, cold patching potholes; and, in the meantime, we put the new back door on the Administration building. That's all I have.

MAYOR HILL:

I will say, once I got out of my drive yesterday, we did have

the best roads once again. That was going through

Lordstown, Newton Falls, Warren Township, Warren City. Those were the four I can compare with and our roads were dynamite. So, you know, pass that on to the staff that we

appreciate it.

MR. HICKOX:

I will. Thank you.

Have you done anything on that social media policy? You

brought it up.

MR. BOND:

I passed it out to everybody. I assume—

MAYOR HILL: MR. BOND:

Do you have any opinion on it? I haven't heard from anyone—

MAYOR HILL:

Yeah, but do you have an opinion on it?

MR. BOND:

Well, I think you ought to take a little bit of a look at it. It was done about 20 years ago, or ten years ago. At that point, there probably has been a lot of changes in social media in that length of time. I have a copy of it here with me. I would appreciate it if people would look at it, see what you

think and we'll go from there.
