MR. LIMING: So moved.

MAYOR HILL: Moved by Liming. Second?

MR. SHEELY: Second.

MAYOR HILL: Second by Sheely. Comments?

(NO RESPONSE FROM COUNCIL.)

All in favor?

COUNCIL: Aye. MAYOR HILL: Opposed?

(NO RESPONSE FROM COUNCIL.)

(VOTE: 6, AYE; 0, NAY; 0, ABSTAINED.)

Motion carried.

Bill, we don't have any bills in here.

MR. BLANK: We don't have any bills.
MAYOR HILL: We don't have any? Okay.

MR. BOND: That's a good thing.

MAYOR HILL: Mayor's report. Per Council rules, I'm required to give a

state-of-the-village address for what has gone on in the year. It's not real lengthy. We've added ten new vehicles to our police fleet, five Explorers. We've got five Tahoes that are

still waiting to be retro-fitted; am I correct?

CHIEF MILHOAN: Correct.

MAYOR HILL: We've had some challenges with fire and EMS. There is a new ambulance on order. And two pieces of legislation that

can go second reading, which we're going to see about getting funding for the Fire Department. I do believe that we have an obligation to the residents to let them know exactly what we're looking for and how it would or would not impact

them. It's only been—in fact, according to what Fire Chief Eastham said he told me, it's what, 18, 20 percent, roughly?

CHIEF EASTHAM: Roughly.

MAYOR HILL: So, you know, that's one thing we definitely want to take a

look at and make sure that we have all the facts out there. We have added dispatch and a police officer to the Police

Department to ease some of the overtime. We've got grants for Bailey Road paving.

New Internet phones, and I don't believe that project is

totally done yet, but we are working on that.

We re-entered an agreement with TEC due to the time lapse

and overcame a lot of sticking points.

I'd like to commend the Clerk and Council President for getting a PILOT (Payment In Leu of Taxes) for the Village. I talked with Chief Eastham. Our ISO rating is staying the same, but we were real close to getting the next step, which, should hopefully, if we get it in the next ISO rating date, we'll be able to get everybody's insurance rates a little lower.

We opened the relocated Hallock-Young Road.

Couple things I'd like to see. One thing is I believe we've

come to the point where we may be needing an

administrator. We have a lot of things which have fallen by the wayside. Everybody says, well—they don't say it but nobody acknowledges—that should be my job or isn't my job. So, I'd like to see us consider that this year. As I said earlier, I feel that we do a good job, maybe even have a public hearing or two over our income tax increase.

I look forward to having a pretty good 2023.

I did get the income tax report. Total income tax collections were \$4,381,226.48. However, some of that will be going towards the school. Whenever we grant abatements, the schools are required—well, they should negotiate with us, but if we don't come to agreements, it's a 50/50 split with the school. So, the school will be getting a pretty big chunk of that. You know, the bad part is, we lose the funds; the good part is, the school shouldn't have to put any more levies on for a while.

Also, during new business, I'll be doing committee appointments. I had everybody's appointment list on the dais here. Also, we'll be accepting nominations for Council President Pro tem.

That is it for the Mayor's report. Is there a Clerk's report this evening?

MR. BLANK: No report, Mayor.

Is there a Solicitor's report this evening? MAYOR HILL:

SOLICITOR DUTTON: No report. However, Mr. Mayor, one of the reorganizational

items is to re-appoint the Street Commissioner.

MAYOR HILL: That's on there. SOLICITOR DUTTON: Thank you.

MAYOR HILL: It's on there. Thank you. Questions for Paul?

(NO RESPONSE FROM COUNCIL.)

Treasurer's report?

MR. EBLING: No report.

MAYOR HILL: No one is here from the Board of Public Affairs.

Village Engineer's report?

Thank you, Mayor. I have a brief report this evening. We MR. KOGELNIK:

had a really productive BPA meeting in December. From that meeting, we've identified that we're going to have a work session this month with the BPA. There probably should be a couple from Council, Utilities Committee that should be there. We shouldn't leave the meeting until the rate study and the rates are established for water. This needs to be addressed immediately. I think I have gone on the record probably a dozen times over the past year saying that that's important to do. So that meeting is going to be coming up here soon. We haven't set a date yet. We will let you know.

I understand from speaking with Mr. Bond that we have a meeting coming up with MVSD this Thursday to discuss the waterline. Thank you for setting that up. Maybe we can discuss the scope of what the Village is wanting to see out of

that waterline from them.

The only other thing I have with Council is I sent to Ron a —Council President Ron Radtka—a draft retainer agreement for 2023 for CT and asking Council for your approval of that. I think you all know how much I put into all of this, especially last year. This year is going to be a lot more activity than even last year. I need some financial assistance from you. Thank you very much. Do you have any

questions?

MAYOR HILL: Where are with our Ultium Cells traffic signal?

MR. KOGELNIK: I don't have an answer for that right now, Mayor. All I can report was from November was that we are waiting for

Ultium to tell us when it's going to be the most opportunistic time to conduct a traffic count in order to get the warrant that we need for the signals. I'll let you know when that's going to be. But I know that the levels of employment are ramping up there. And from what I can see, when I use State Route 45, the amount of use at that driveway is really picking up. And I've seen some—I don't want to say near misses but it just doesn't look like it's organized coming out of that driveway and onto State Route 45. I think maybe you have seen that, too. I'm getting concerned about that. So that signal is a must.

Any questions for Chris? MAYOR HILL:

About that traffic signal, when Senator Rulli was here not MR. BOND:

> too long before the election this fall, he said with things going on with development, if we need financial assistance, we ought to let him know early in the year so he can get it in the budget. I think probably something should be done along

that line.

MAYOR HILL: Bob, that goes back to the who? You know, people can

> bring up all these fabulous ideas but then who is going take the responsibility? You know, and that happens quite often

around here.

MR. BOND: That might be something for one of the committees. I'm just

saying what he told us when he was here.

Okay. Thank you. Any other questions for Chris? MAYOR HILL:

> (NO RESPONSE FROM COUNCIL.) Hearing none, special reports. Police Chief Milhoan?

Yes, Mr. Mayor. I've submitted my yearly report for 2022. I **CHIEF MILHOAN:**

emailed it to all of you today. I'll answer any questions if

you have any.

The only other thing I have, I also emailed you and cc'd members of Council to remove Nicholas Leonardo tonight.

Just wanted to make sure you got it.

MAYOR HILL: Okay. Any questions for Brent?

(NO RESPONSE FROM COUNCIL.)

Fire Chief Eastham?

Yes, Mr. Mayor. We ended the year with 958 runs. And, CHIEF EASTHAM:

> also, we got denied both FEMA grants that we applied for this year—last year in 2022. Other than that, that's all I have.

MAYOR HILL: How soon is that new ambulance supposed to be coming?

Do you have any idea?

CHIEF EASTHAM: Should be July or August.

MAYOR HILL: Thank you. Any questions for Travis?

(NO RESPONSE FROM COUNCIL.)

Planning and Zoning Administrator, Kellie?

MS. BORDNER: Yes, Mayor. I provided multiple Planning and Zoning

reports for 2022 to each of you, consolidations, subdivisions, zoning permits, certificates of occupancy, zoning fines collected and a Planning Commission report. In addition to those reports, I just want to recap that in 2022 we had over six property consolidations, 12 property subdivisions involving two parcels or more, issued approximately 70 zoning permits, collected over \$23,000 in permit fees, issued over 50 certificates of occupancy, and collected over \$3,700 in zoning violation fines. Last year we were able to clean up all outstanding certificates of occupancies from prior years.

That's a first. We currently have only approximately 12 outstanding certificates of occupancy for zoning permits that were issued in 2022 with almost half of those being single—family dwellings that are not completed and/or that do not have a healthy stand of grass yet. So, we are staying very current on our zoning permits and subsequent certificates of occupancy for structures in the Village. I'll be happy to answer any questions that any of you might have.

MAYOR HILL: Any questions for Kellie?

(NO RESPONSE FROM COUNCIL.)

Very good report.

Hearing none, Parks, Grounds, Buildings, Street

Superintendent, Ron Hickox?

MR. HICKOX: Thank you, Mayor. Over the Christmas holidays, our crews

were dispatched for snow and ice and we made it through the storm. And with all that then, we restocked our salt supply

today.

Now with the weather going this way, we are cold-patching potholes, and we'll be out doing the same for the next week

or so.

We've been attending to the Christmas lights and keeping them lit and now we're getting ready to turn them off and

take them down.

I will attend a scrap tire grant meeting on January 16th, I

believe, if the Village wants to reapply through

Trumbull/Geauga Solid Waste District for our scrap tire

grant for next year. That's all I have.

MAYOR HILL: Thank you. Any questions for Ron?

(NO RESPONSE FROM COUNCIL.)

I believe that we have always used the scrap tire grant. Is

Council wanting to do it again?

MR. LIMING: Yes. MR. RADTKA: Sure.

MAYOR HILL: There you go.

MR. HICKOX: Very good. Thank you.

MAYOR HILL: Thank you.

MR. LIMING: Trucks all running?
MR. HICKOX: As of this moment, yes.

MAYOR HILL: Bill, do we have any correspondence this evening?

MR. BLANK: No correspondence, Mayor.

MAYOR HILL: Public remarks?

(NO RESPONSE.)

Hearing none, Council remarks.

MR. BOND: Yes, Mr. Mayor, at the last meeting we discussed these

grindings. I've looked up the O.R.C. And the Village one. The Village one needs to be updated. It's supposed to have been advertised annually in the Village newsletter. We no

longer have the newsletter—

MAYOR HILL: We do but it's online.

MR. BOND: Pardon? MAYOR HILL: It's online.

MR. BOND: Okay. I think some years it got somehow not in the Village

newsletter as it should. So then there's an O.R.C. Section that states what occurred shouldn't occur. I've got to say I think our oath of office requires us to look at these things. I gave a copy of this to Paul. Paul, maybe you can give us a

way how to stay out of trouble on stuff like this. The one local one was put into effect in 2015 and the state one went into effect a lot sooner than that. Could you address that a

little bit for us?

SOLICITOR DUTTON: Well, the bottom line here is that we have to go through a

certain protocol and procedure when you are disposing of these grindings. And it's basically letting the world know and coming up with some way in which the general public

can bid on them or ask to bid on them.

MR. BOND: Well, I know the Mayor said we have these big piles of

them-

SOLICITOR DUTTON: Right.

MR. BOND: —and Ron said the same thing.

SOLICITOR DUTTON: Right.

MR. BOND: Why don't we advertise some of those as a bid. If we got

more coming in, we've got more than we need and get rid of

it—

MAYOR HILL: Well, Bob, who is going to do it?

MR. BOND: Who is going to advertise? That's what you're telling—

MAYOR HILL: No, well, I keep telling you, Bob, you bring up a lot of points

with a fear, but it's great to bring them you but whose ich is

quite often, but it's great to bring them up, but whose job is

it?

MR. BOND: Well, Mr. Mayor, not everything falls into a neat little thing

like that but what we've got to do on this—I don't expect anybody to be an archivist and know every law the state has passed and be familiar with every ordinance that Lordstown

has ever passed. That's asking quite a-

SOLICITOR DUTTON: Well, in this case, Karen Jones, when she was on Council,

raised the same issue about five or ten years ago.

MR. BOND: Yes.

SOLICITOR DUTTON: And when we were just giving these away to friends and

family so—

MAYOR HILL: Well, some family member didn't get it. That's why it was

raised by Mrs. Jones.

MR. BOND: Well, I don't know about that. That's seven years in the past.

But what I am saying is we can't continue like this. We're in

a mess here now on these so-called-

SOLICITOR DUTTON: We have an Ordinance, even though the Ordinance may not

be completely up to—in accordance with the state statute. I

would follow the local Ordinance and the Street

Commissioner should work with the Clerk to advertise for these piles that we say are there and see what the response is.

MR. BOND: Well, that's my thinking. Turn it into cash and we avoid

problems like this.

SOLICITOR DUTTON: Well, there are some people—we may end up no one might

bid on them.

MR. BOND: That's true.

SOLICITOR DUTTON: People may want them, but they may not want to pay for

them. So, see what comes of it.

MR. BOND: We'll have to decide if we're selling the whole pile in one bid

or how it's going to be done. I know there are companies that make a business out of selling these types of things.

SOLICITOR DUTTON: Resell-

MR. BOND: I talked to one today up in Newbury and they sell them for

25 a yard is what they're getting for it. Now, I don't know

how many yards these trucks hold but I think it's a

considerable sum. I think it needs looked at. I think we need to make an effort to do better on that. And I don't think an

administrator would cure that problem.

MAYOR HILL: I'm not saying an administrator would. But, Bob, as I told

you, when this came to light, I told you you could have gone and talked to Mr. Hickox over this and you said "well, I'm not an administrator." Well, you don't have to be—

MR. BOND: Well—

MAYOR HILL: Hold it. Let me finish. You don't have to be an

administrator to just sit and talk to the Street Commissioner and say, "I don't know if you're aware of this." And then you totally left me out of everything and I'm the administrator as far as the top executive of the Village. But then you were doing everything, sending it to everybody else in the world

but me.

MR. BOND: I send it to you when you ask me to.

MAYOR HILL: You should have sent it right off the bat, Bob.

MR. BOND: When you put it that way, thing of it is, this is the law. We

have all taken an oath to take and abide by it and enforce it. And the thing is, we can't just turn our nose up. If something happens after the fact, then the public is completely left out. I guess everything is nice and hunky-dory, I guess, as long as

the public doesn't find out.

MAYOR HILL: Well, that may be your opinion. That's not mine—

MR. BOND: Well, it sometimes looks that way.

MAYOR HILL: Okay, well, we will get that addressed. Hopefully some

committees will take a little bit more interest in some of the

responsibilities, you know, especially like the Utility

Committee. That's been lacking in the past. I know we don't have anybody here from the BPA but I know they were very appreciative that we actually had Council representation at their meeting, which the Utility Committee does have a slot on their agenda. So, hopefully, 2023 people who—Council

will be a little more active on certain committees.

Any other Council remarks?
