I would like to keep a senior services—or a center here, but I don't know whether there would be any involvement from the Village or not. But if we could get

someone to go to that meeting, I'd appreciate it.

That's all I have for new business. Is there any other new

business at this time?

MR. RADTKA: Yes, Mr. Mayor. I'd like to make a motion for a work

authorization for CT Consultants for the proposed battery plant, land development plan review services, final plan review to construction, as needed. It's for engineering services to perform the reviews for mass grading the final grade submission packages in accordance to the Village Codified Ordinances. It's not to exceed \$28,000, which is

reimbursable to the Village.
