Both gentlemen have completed everything in our process, with the exception of the physical. So, pending the physical, they'll be able to start. I did email their bios to you and also

placed them in your mailbox.

That's all I have.

CHIEF EASTHAM: Yes, Mr. Mayor. Just so you're aware, Kellie and I when we

> reported on the park picnic, we only spent about \$1,200 out of the \$3,000 that was allocated. Instead of asking for more money for the Christmas tree lighting, we were just going to see if Council is okay with us using some of that \$3,000 we didn't use. We won't be using \$1,800. But it's already been authorized, so we were just hoping to roll that over to where we'd use some for refreshments and donuts and things like

MAYOR HILL: Anybody have a problem with that?

(All Council members responded in the negative.)

Okay. You're good. MAYOR HILL:

CHIEF EASTHAM: Thank you.

Planning and Zoning Administrator, Kellie?

MS. BORDNER: Yes, Mayor. Thank you. Chief Eastham and I have been

working with Ashley Yuhasz, Trumbull County Land Bank Administrator and Member of the Trumbull Neighborhood Partnership, along with Rod Hedge of the Trumbull County Health Department on determining that seven structures in the Village are unfit for human habitation. We have one structure that the property owner is currently working to restore and six that are listed in the legislation for consideration tonight. Of those six, two are still being considered for unfit status by the Trumbull County Health Department and are anticipated to be deemed unfit at their

November 15, 2023, meeting. If Council passes this

Ordinance tonight, it will allow Chief Eastham and I to move forward in working with Ms. Yuhasz to effect the demolition and removal of the subject structures. We will be able to do this based upon grant funding that is available, and any minor costs not paid by the grant funds and which are paid by the Village will be placed against the corresponding properties as liens. If this passes tonight, the next step for the Village would be to give notice to the property owners and lienholders of record of the Village's declaration of nuisance and intent to abate the structures by demolition and removal. We generally do this by certified mail and we will; however, it is very typical with these structures (which have been in violation and recipients of certified mail from the Village before) that they do not sign for the certified mail and it

comes back to us undeliverable. Therefore, we would not only request that Council approve the legislation tonight but also permit Chief Eastham and I to further provide notice to the subject property owners and any lienholders by legal publication in the Tribune. So, we would ask for a motion to be permitted to provide legal publication under new business.

Additionally, I have provided all of Council, Solicitor Ries and department heads with information from the EPA on the 2022 Toxics Release Inventory for two businesses in the Village, which have made the list, Ultium Cells and Matalco.
