Mayor's report. You know, I was hoping that I could have gone out as Mayor—I'm proud of my record. But it seems like one of the candidates wants to put me in the middle of this campaign. I want to read a letter I had—I put a postcard out after the last election. It says, "Dear Lordstown residents: I cannot allow my opponent to accuse me of misleading you about the facts I have presented without responding. I wish that a debate had been organized so we could answer residents' questions rather than be subject to social media pundits. Most voters were aware of the issues and the differences in agendas between my opponent and myself. Please don't let his twisting of information sway your vote. He gives his personal opinions on the facts I've shared in his most recent postcard. Look at the Trumbull County Auditor's website and see that there is no 2018 tax rate lower than Lordstown's 59.300 mills. I want income for our businesses to continue to cover services provided by the Village. Who says all Lordstown property is now correctly zoned? In the referendum vote, 76 percent of the voters agreed that TJX property was not—we didn't do what was wrong. We did what was right. The second power plant is in financing and will submit to Planning soon before a groundbreaking next Spring." Well, that has been postponed. "I stand on my record of public service. I've always heard that if you don't have a record to run on, you tear your opponent down, as shown in Mr. Bond's latest postcard. I love this Village and will continue to do everything I can to maintain our standard of living as I have since first being elected in 1992. I would appreciate your vote Tuesday. Arno A. Why am I even brought into this election? You know, I've been fighting issues. I just want to go out, be proud of my record. I don't want any more garbage being put out or be thrown in the middle of it. I had one candidate who has been coming after me for seven years. I got complete fliers—files. If you want to keep coming after me, keep coming. I'll just start breaking out more.

There's a group of people who said, you know, after the last flier came out and I was involved, they say, "why were you even brought in?" And I'm not the only one who got phone calls. This is getting to be old, folks. I'm proud of what we've accomplished. If the candidates want to come and come after me, I'm ready.

There's even people that want to sit out front campaigning on election day with circles with slashes with two candidates names in them. I don't want that. Leave me alone. I'm proud of what I've done, what we've done as a Council. If I hear anything else, I'll be loaded for bear.

I submitted my report to everybody, Mayor. We have a few active things coming up. I just received that email from

Solicitor Ries announcing that on, I think it's October 26th, the heavy hauls—I'm sorry. Not Matt Ries, but our Police Chief—that heavy hauls would begin on October 26th from the Ohio Commerce Center down to TEC site. So, Ron, we're going to need to keep an eye on that.

The TEC group is wanting to start the construction of their cross connect on State Route 45. This is the 16-inch waterline that's a redundant connection, normally closed, that would feed the power plant in the event that the 24-inch that they're designing and building would go down. So, that project is going to begin here fairly soon.

Those are the more significant items I have. We've been busy this past month. We helped the Village to submit two ARPA applications. And I want to thank the Mayor for mentioning that the county had some ARPA funds that they were looking to possibly have the Village utilize. And so those things can not happen without communication. So, we were able to quickly put together two applications to get into the hands of Cindy Slusarczyk and she properly got them over to the county. So, best of luck with getting funding with those. That's all I have. If you have any questions.

MAYOR HILL:

Any questions for Chris?

Yes. Do you have an idea where we're at with this RUMA agreement?

MR. KOGELNIK:

Maybe I'll let Solicitor Ries go over that.

SOLICITOR RIES:

I actually just got an email this evening at 5:13 from TEC's counsel. The only two things we're waiting on are an approval letter from the county. The county engineer is going to sort of oversee things, mediate if there's a disagreement. So, we're waiting on a letter of approval from them, which has been in the works for a long time. This has been between TEC and TEC's counsel and the county. Frankly, we've been waiting for several months. We were also waiting on a letter of credit that's acceptable that's going to be attached to the RUMA. They just got me that letter of credit today, and I forwarded it to several of you to review. But that just transpired, like, an hour and a half ago.

MR. BOND:

Chris, have we heard anything more other than what you have here in your report on Henn Parkway?

No, we haven't, and we're back to square one with figuring out a way to help drain that line coming from M&M. There's nothing I can say that's going to be definitive right now, Ron. We need to regroup and get some clarification from the property owners.

CHIEF MILHOAN:

Yes, Mr. Mayor. I just ask for Council's support on the first Ordinance that has to do with the purchase of the body cameras and tasers. I would ask that they pass that emergency so those items can be purchased.

Also, I would ask that they amend the second Ordinance with the new quote. And, also, pass that emergency so those items can both be purchased before expiration of the quote date. That's all I have.

Fire Chief Eastham?

CHIEF EASTHAM: Yes, Mr. Mayor. Friday afternoon about 10 in the morning we did receive the delivery of our ambulance that we ordered a year and ten months ago. We finally got it. It's in service and it is being used. We're probably going to have to look towards the end of the year looking to start specking another one because it's going to be three to four years if you order now. We're going to have to roll dice and see how long we can go before we think we can order another one.

MAYOR HILL: Unless we found another vacant chassis sitting around somewhere.

CHIEF EASTHAM: It still has to go into the build—it knocked, I think it was 14 months off to go with the Ford chassis. If we would have stuck with the Chevy chassis that we had specked, it would have been another 14 months. But there was a cancellation, so we got to slide it in and took it's place or we would have had an even longer wait. At least it's here and it's up and going and everything is good.

We continue mowing roadside and parks and grounds. We're cold patching roads throughout the Village, and I'm doing drainage repairs. We're getting our snow equipment out of storage and starting to get that into our rotation to get it ready. We started Christmas decorations today, rebuilding. We got materials ordered for the east Foxconn gate that was damaged in a traffic accident back in January. I'm told it could take up to a year to get the poles. We're working on traffic lights at some of the Foxconn gates that are down, and they're trying to re-establish those and get the loop detectors working so they function correctly when traffic pulls up. That's all I have.
