Fire Chief Eastham?
CHIEF EASTHAM: No report tonight, Mr. Mayor.
MAYOR HILL: Questions for Travis?
(NO RESPONSE FROM COUNCIL.)
Planning and Zoning Administrator, Kellie?
MS. BORDNER: Yes, sir. We have a Planning Commission meeting on October 10th at 6:30.
And just also wanted to remind everyone that the community picnic is on the 7th, this coming Saturday, from 1:00 to 4:00.
MAYOR HILL: Any questions for Kellie?
MR. RADTKA: Yeah, one thing. Kellie, you want to just give us a quick update on this work authorization real quick of what it entails that I'm going to be making during the—under new business?
MS. BORDNER: Yes, absolutely. It is a work authorization to have our Village Engineer review a plat. It's called the Krisher plat. It is off of Tait Road. It will encompass two lots, one and two. The reason that it has to be contained within a plat is because there are additional tiny little parcels that they were unable to either contact the owners of or they are deceased or there's a great deal of taxes owed and nobody is responding. And so those have to be—for lack of a better word—accepted out of the plat for lots one and two per the county's requirement. So we have to then follow our plat process. And even though it will be on an abbreviated review—it wouldn't be a normal, major sub—division plat. It will be on an abbreviated—type review, but we also need the Village Engineer to do that.
MAYOR HILL: That's those little postage stamp lots at the northeast corner of the Village, correct?
MS. BORDNER: It's off of Tait Road, so it's right next to—it actually includes where—
MR. RADTKA: Here (indicating on map.)
MS. BORDNER: —Mr. And Mrs. Robert Krisher live.
MR. RADTKA: Just kind of to clean up a lot of those small lots and combine them together.

MAYOR HILL: A lot of those lots have been around forever and nobody ever did anything with them.

MS. BORDNER: Correct.

MAYOR HILL: Okay. Any other questions for Kellie?

Parks, Grounds, Buildings, Street Superintendent, Mr. Hickox?

MR. HICKOX: Thank you, Mayor. Our crews have been busy working on drainage issues at various locations.
We've been roadside and grounds mowing.
The park has hosted a cross-country meet and a soccer meet the previous two weekends.
We have the traffic lights on Hallock-Young Road in front of the Foxconn plant up and running again.
Hewitt-Gifford Road for OPWC funding, the next meeting is on the 19th of October. That is when the first points are awarded.
I was contacted by CT Consultants. They want to try to have a roof pre—construction meeting on Tuesday or Wednesday of next week. I got back to them and both dates work for me, so whatever they came up with.
Our mower for our excavator is still down and I'm pursuing a rental so we can get caught up on some of these off-site, off-road mowing that we have to do. We have some sight distance complaints at some areas around guardrails and various other places.
I would also like to ask Council for permission. We are down two personnel in our department. I'd like to ask permission to advertise for two labor, truck driver, operator positions that have been vacant for over a year. One of them has been vacant almost two years.
That's all I have.

MR. CZOKA: Tom Czoka, 1211 Hallock-Young Road. I'm going to speak just for Hallock-Young Road because that's what I know and I can speak the truth about. We had a problem a while back when they were building Ultium with truck traffic, tractor trailers going up and down the road. Kind of went away for a while. Well, now it's back for some reason.
In particular, I had one Wednesday come down there. He must have had construction stuff on a flatbed, soft-sided, spread axle and he started to back up onto Goldner. Well, when they do that, they get up into my yard because they can't make that swing. So I went out and talked to him. I said, "where are you trying to go?" And he said, "I don't know." He spoke broken English. This isn't the first time this has happened. I said, "what's the name of the

company?" He said, "I don't know." I said—and he pulled his phone out and he showed me his phone and there was a text on it. And it said 1800 Hallock-Young Road. And this isn't the first time they've missed 1800 Hallock-Young Road. I know where 1800 is. I think it's the old Anchor building. That is the driveway right across from the Turnpike, the old Anchor. Well, I went down there and looked and there's 13 signs on that fence, but not one has the address. These poor guys—I mean, you've got to blame the truck drivers. But we need an address down there. If there was an address, all those construction companies—these guys are coming in with construction loads and every name of the company is different but they all have the same address, 1800 Hallock-Young Road. So, if we could get—I don't know who owns the property whether Foxconn does. Back then GM did. I know when Leaseway was there. I don't know if they sold it to Ultium or the Village. But we need a sign designating 1800 Hallock-Young Road. I think it would eliminate a lot of the problems. A couple weeks ago we had the roads shut down down here. Liming, you probably know that. The truck went past my house, so he was probably looking for 1800 Hallock-Young Road. He ended up going over and he got broke down trying to make a left going over the Meander bridge with a tractor trailer.

MR. LIMING:

The whole load shifted.

MR. CZOKA:

The whole load shifted and the truck came up off—

MR. LIMING:

The wheels were off the ground.

MR. CZOKA:

They shut down the road for hours down there. It probably could have been eliminated because that truck went by my house.

About a month ago, for some reason, a Cassens truck come up the road. Now, what the heck a Cassens truck was doing on that road, I have no idea. I don't know where he was coming from but he was going west. He had to come on all those posted roads to get there.

MAYOR HILL:

I agree with you. One problem we've had in the past is there's your phone GPS and there's an actual truckers' GPS I've been told. A lot of times—the people you can't talk to use their phone. They don't use the truckers' GPS. But if Council doesn't have a problem, Ron, could we make a sign for 1800—

Sure.

—Hallock-Young Road? And have Ron make one and get it put up there. Nobody has a problem with that, do they?

MR. CZOKA:

We need to have it big enough, not just the little house numbers because it will blend in with all those others. If there was a sign there, that would eliminate the problem we're having, I'm sure. These guys don't want to be on those posted roads anyway.

MAYOR HILL:

If you could do it in the next couple days, Ron, Council won't have a problem. We'd appreciate it.

MR. CZOKA:

Thank you.

BORDNER: From Public Safety and the Police Department Committee for Emergency Passage, **AN ORDINANCE ACCEPTING THE QUOTE FROM AXON ENTERPRISE, INC., 17800 NORTH 85TH STREET, SCOTTSDALE, ARIZONA 85255, FOR THE PURCHASE OF BODY CAMERAS AND TASERS, INCLUDING HARDWARE, SOFTWARE, SERVICES AND WARRANTIES, SUCH QUOTE BEING THE MOST RESPONSIVE, LOWEST AND BEST QUOTE AND DECLARING AN EMERGENCY.**

MAYOR HILL: Comments or motions?

MR. LIMING: I think we need more discussion on that.

MAYOR HILL: Say you'd like to have more discussion on it.

MR. LIMING: I'd like to have more discussion on it.

MAYOR HILL: First, let's get it on the floor. Motion and second and then get it on the floor for discussion.

MR. LIMING: I make a motion—suspend the rules; is that what we've got to do?

MAYOR HILL: Yes.

MR. LIMING: All right.

MAYOR HILL: Motion by Mr. Liming to suspend the rules. Is there a second?

MR. RADTKA: Second.

MAYOR HILL: Second by Radtka. Roll call, please to suspend the rules.

MS. BORDNER: Mr. Campbell?

MR. CAMPBELL: No.

MS. BORDNER: Mr. Sheely?

MR. SHEELY: Yes.

MR. LIMING: Comments or questions?

MR. LIMING: So, if I'm hearing you right, we could get the body cameras and the tasers and pass that motion and not get the car cameras. I know the price is going to be different, correct?

CHIEF MILHOAN: Correct.

MR. LIMING: And then at a later time, we could get the car cameras and that. The system will be in place to do that if we wanted to?

DET. BORDONARO: Everything else would be in place, all the—yes, the evidence end of it, the storage will all be set up—the body cameras and the tasers.

MR. RADTKA: So, we could piecemeal this however we wanted. If we want to get the body cams and the car cams and not the tasers or any which way, we could—we have options.

DET. BORDONARO: Well, you can, but that will definitely drive your price if

you're piecemealing it.

CHIEF MILHOAN: You can buy ala carte. If that's your question, you can purchase ala carte. You can purchase tasers and say no on the other two. You can purchase body cameras and say no on the other two. You can purchase all three, but everything changes price wise.

MR. MOSELEY: Why does the price have to be up today or tomorrow or whatever?

DET. BORDONARO: So, we were given two forms of discounts, is how he explained it. One because we were bundling. It's no different than your Internet, your home phone, you know, all that. It's the same concept. And then the salespeople who we were dealing with are allotted so much money and discounts to allot per quarter. So, we're working with this kid, doing a little negotiating with him trying to get the most bang for our buck. The combination of those savings are listed on each contract.

MR. MOSELEY: Well, if he wants it, he'll have to work a little harder to get it.

MR. LIMING: If I'm hearing you correct, if we would pass this, then you can apply for that grant because you will know—

DET. BORDONARO: There's no guarantee with that grant.

MR. LIMING: No, no, but you can apply for it.

DET. BORDONARO: We can apply for it.

MR. LIMING: Because you'll know what body camera you have and everything, correct?

DET. BORDONARO: Out of this one, correct.

MR. LIMING: And that's what the grant is for is the body camera.

DET. BORDONARO: Just for body cameras.

CHIEF MILHOAN: Just for body cameras, not for tasers or in-car, correct.

MR. RADTKA: Could we not apply for the grant and input that information into that grant application—

DET. BORDONARO: That's what I would have to do.

CHIEF MILHOAN: That's what he would do.

MR. RADTKA: But you have to purchase them prior to the grant.

DET. BORDONARO: No.

MR. RADTKA: So we could wait.

DET. BORDONARO: You could wait to see how the grant shakes out. But if I put in that the body cams are, say, \$20,000 out of the \$31,000, that's the body camera cost. And if we get approved for that, but if the price of the body cameras then go up, then you're not fully funding—

MR. RADTKA: Oh, sure.

MR. LIMING: Right.

CHIEF MILHOAN: You'd pay the difference.

MR. RADTKA: Right.

DET. BORDONARO: And as a reminder, these costs are equally split up—

MR. LIMING: How long does the grant take to—

DET. BORDONARO: They don't give you a deadline.

CHIEF MILHOAN: We don't know when—

DET. BORDONARO: It's marked as 2024 funds, so I would assume that it will be 2024 whether that's when they make award announcements or they can make the award announcements before the end of year and then they'll tell you when you can apply to receive the funds. But these costs are split over five years.

MR. BOND: We buy these and pay for them, how are you going to accept a grant? Because it was something that was already

purchased—

DET. BORDONARO: We haven't been able to get a clear answer on that. We're trying to figure out if we did purchase them outright because we're splitting these costs over five years. We ask for a year's worth of coverage through the grant, ask for \$20,000 to cover 2026 portion of the cost, or 2025, whatever.

MR. BOND: I'm surprised—I have to admit that the purchase of this expense, I'm surprised you hadn't talked to Finance before the committee meeting.

CHIEF MILHOAN: I wasn't aware I needed to do that. I've never done that before.

MAYOR HILL: Normally, whenever something comes up through a committee, the committee approves it. And when it comes— Council sets the agenda. But the Finance Committee does not have the right to not accept legislation from either—

MR. BOND: I'm not saying that. I'm just saying—

CHIEF MILHOAN: I mean, nobody brought that up at the meeting.

DET. BORDONARO: Nobody asked—you didn't ask us that at the meeting.

MR. BOND: I presumed you—

MR. LIMING: Well, we didn't—

CHIEF MILHOAN: In the past you've never done that.

MR. CAMPBELL: —we didn't have anything on there, right.

MR. RADTKA: Your meeting happened after—

MR. LIMING: The agenda for that came out.

MR. RADTKA: Correct—so—

DET. BORDONARO: Is there a threshold that then we should ask just so we know for the future? I mean, is there a threshold?

MR. RADTKA: Like I said earlier, 99 percent of things are, you know, Bill gets the agenda prepared for Finance at the end of the week, the week before Council. The majority of things are run through Finance—

MR. LIMING: All the police cars went through—

MR. CAMPBELL: I'm just saying this and I think everybody should just think about it a minute. With today's world, the shape it's in, it's so damn sad to see all the number of police officers getting shot or killed on a daily basis. I think we need to get something that we have to sort of protect our officers. We don't have the officers that we had when I retired. Everybody is needing police officers on a daily basis. Just ask the departments. So I think this is one thing that is very important.

MR. LIMING: I'm kind of of the opinion we get these body cameras and tasers. They have all but two cars with cameras in them now and we can—maybe we're kicking the can down the road. We can address that at a later date. You couldn't get them for ten months anyway, correct?

CHIEF MILHOAN: Correct.

MR. LIMING: Maybe if we wait five months, it would be a year or something.

MR. RADTKA: My only concern was just the affordability.

MR. MOSELEY: How many body cameras does that get you?

DET. BORDONARO: Thirteen.

MR. LIMING: Is there going to be any grants coming down the road for the in-car cameras?

CHIEF MILHOAN: Not that I'm aware of.

DET. BORDONARO: All these grants, some are for equipment in general and they

specify, so it could be. But body cameras are exclusive to them.

MAYOR HILL: Any other discussion on this?
(NO RESPONSE FROM COUNCIL.)
Anybody want to make a motion?

MR. LIMING: I make a motion to accept.

MAYOR HILL: To adopt?

MR. LIMING: Adopt.
