MR. KOGELNIK: Been working with Darren regarding the waterline that keeps breaking in front of the Antonine Sisters. We may be positioning the Village for an emergency funding application through OPWC to replace that section of the waterline, which would help. If that doesn't work, you might have to go out and get a loan to replace that section of the waterline. It's in bad shape. It's my understanding it's not that old, that waterline. So that's why I'm thinking that line might be eligible for emergency funding. So that's kind of a top priority since that feeds the Antonine Sisters. We've also coordinated with the Village for the extension of the water main on Woodridge Way. And I think this week we have a meeting coming up with Ultium—

MR. PETERSON: That is correct.

MR. KOGELNIK: —on Wednesday, October 5th—

MR. PETERSON: Yes.

MR. KOGELNIK: —Wednesday, the 5th. So anybody that wants to go to that, that's the BPA meeting. We've invited Ultium to that meeting, and Mr. Tom Gallagher will have his representatives at the meeting. Also, we've worked on the traffic signal in the coming week. I may have to ask for the Village to sign the permit application that has to be submitted for that project. Do you have any questions for me?

MR. BOND: Yes, Chris, that waterline down there by the Shrine, why does it keep breaking?

MR. KOGELNIK: We don't know, but we suspect it might be because of pressure swings caused by Ultium, of which we're going to talk with them at this meeting. We've even begun that discussion with them. We can't prove that. It could be a compounding problem, too, meaning that there's a gas line that is very close by and there could be an impressed current through the ground, which Darren has showed that the pipe is heavily corroded. So, it could be a combination of issues. We don't know.

MR. BOND: Okay.

MR. KOGELNIK: So—

MAYOR HILL: What size is that pipe?

MR. KOGELNIK: I think that's an eight.

MAYOR HILL: If I recall correctly, probably 30 years ago, they had extended some pipes down on Gladstone Road. I think the BPA was not coming to the Village at the time. I wasn't Mayor. But I think some places they only put, like, a two—inch line down there.

MR. KOGELNIK: In the past, that could have been done. Now, if anybody has any records of that waterline in front of the Antonine Sisters, we really need that information. OPWC will sniff that out. We need to prove that the line is the Village's and it was maintained.

MAYOR HILL: I believe that somebody other than the Village put that in, but I can't say for sure.

MR. LIMING: It hasn't been 30 years—

MR. BOND: That was—how long ago was that put in, Chris?

MR. KOGELNIK: The best we can tell is that it was around the middle 90's, late 80's, middle 90's.

MR. BOND: That was 30 years ago.

MR. KOGELNIK: So, you know, a waterline by OPWC's definition has a useful life of 40 years, but waterlines should last longer than that.

MAYOR HILL: Things were run differently way back when, when the Village was supplementing the BPA to keep them afloat. And I know that sometimes there may have been Ordinances which were passed by the BPA which didn't come to Council, I believe. You might want to check the records on that.

MR. BOND: Is that a ductile iron line?

MR. KOGELNIK: To the best of our knowledge. It wouldn't have been cast at that time. Cast was popular in the 70's.

MR. LIMING: Wouldn't the original line gone up to the Shrine and then added on to that to go down to that assisted living?

MR. BOND: That's what I thought—

MR. KOGELNIK: Yeah, that's—

MR. LIMING: So which is blown out?

MR. KOGELNIK: The one going down to the assisted living.

MR. LIMING: So that shouldn't be that old—

MR. BOND: It can't be—

MR. KOGELNIK: That's what Darren is saying, too. So, we need to prove this. We need to prove our case so we can substantiate and justify to OPWC, this is why we need this money. You could be very well lining yourself up for an 80 to 90 percent grant for the replacement of that line, which is good.

MR. LIMING: Because that should have just been added on whenever they built the assisted living.

MR. KOGELNIK: So, if you have any information, call me. That's all I have.

MAYOR HILL: Any other questions for Chris?  
(NO RESPONSE FROM COUNCIL.)  
Thank you.  
Police Chief Milhoan?

CHIEF MILHOAN: Yes, Mr. Mayor. You'll see during the month of October, some of our officers will be wearing these pink badges. It's to show the breast cancer awareness during the month of October. Some of the officers purchased them. So I just wanted to make you aware of that.  
I submitted my monthly report for the month of September if you have any questions. On Thursday, I emailed all of you about whether you would support purchasing three more police vehicles. I'm just curious as to—I know not all of you are here tonight—but just curious as to what your thoughts were on that. I emailed it to you Thursday so you could have time to think about it. Just wanted to know where you stood on it, yay, nay, not sure.

MR. LIMING: We have to do the roof, don't we, on the police building next year?

MR. BLANK: (Nods affirmative.)

MR. LIMING: I mean, that's the plan. I mean, to me it was better to see what we're going to have in that before we go for more cruisers.

MAYOR HILL: I think at the next Finance meeting, you should find out how much money is actually there for capital improvements. Because I will tell you in the years past—and I talked with Bill briefly about this—you know, when department heads would submit what capital improvements, they felt needed be done and then I met with them one on one and then we

went through. The Clerk always said this is how much money we have. We're getting to the point now that we are getting some money in now. I would like to see it go back to that so that way department heads know what they can plan for the year rather than everything has to come in and be a begging process.

MR. CAMPBELL: These three, when do they have to be ordered to get here due to the fact everything is backed up?

CHIEF MILHOAN: We don't know, Terry. They've already closed the—you can't place an order. The date to order—whether you go with a Chevy or Ford, the date to order is closed. Chevy closed in May; and Ford closed September 9th. So, we missed the opportunity to place an order. But there have been a number of dealers that have placed orders for units that they're hoping to get. They haven't arrived yet, but they have been very clear that once they arrive and they're sold, that's it. You know, there won't be any more. So my hope is that we would be able to get one or two or three of those if they get them.

Like I said in my email, North Jackson ordered their vehicle a week after us, just one week. Their order was placed and accepted but then they received an email that their order was cancelled. So, the car that we ordered that's going to be the K-9 car, we got it just in time. If we would have waited another week, we'd be in the same boat that Jackson is in. It's very difficult. These are—we haven't had to do this before. It's unusual. It takes an awful lot of time. We saw the increase that the Ford did just in a year. It was \$9,100 higher. I'm not making a statement that it's going to go up another \$9,100, but it could. And I don't know what the price of the Chevy is going to go. I don't know how you feel towards the Ford or how you feel towards the Chevy.

Maybe some of you feel differently. I don't know. I just tried to give you as much information as I could so you can make an educated decision. I said in my email, you know, I know initially I told you—and the information we were just passing on from our upfitter—that he said that the Tahoe was more to upfit it. Then after he told me and I shared that with you, he called us back and said he made a mistake. Because there's some of the things that we have to purchase for the Ford for the upfit that comes standard on the Chevy. So it made the price a little bit—you know, the difference between them a little bit lower. Somewhere around \$700, roughly. So, I can't—if you told me right now to go buy three, I don't even know if we could get them. I was just asking if the Clerk says we have the money—and I haven't talked to Bill—if the Clerk said we had the money for one or two or three more, I just didn't know what your feelings were. I know this is something we can't wait on. So I was just looking—

MR. CAMPBELL: The way the mileage is on all the other cars, I understand where you're at.

CHIEF MILHOAN: I tried to give you the information on the five Chevys that we have with the mileage. Like I said before, it's really up to you. I'm asking for what I think we need. But if you want us to share cars, we can do that. We can share cars. I just—whatever you want to do.

MAYOR HILL: The only thing about sharing cars is then the mileage goes up on them so fast.

CHIEF MILHOAN: It does. I think we all understand that.

MR. BOND: They're generally gone before they're rusted out too—it's a two-edge sword both ways. I think Lamar is right. We ought to see what the money situation is before we do anything.

MR. LIMING: I know Terry said we've got to get that roof done, correct?

MR. CAMPBELL: Hopefully, yes.

MAYOR HILL: Any other questions for Brent?

CHIEF MILHOAN: Yeah, the only other thing I have—I guess I'm just asking for some clarification. Two weeks ago we had a Council meeting and we were discussing cars. And I guess I just need some clarification from Councilman Reider. During the discussion of the cars, Mr. Reider had a question that said "you're going to make sure that these are going to be for our patrol officers, correct?" And I said, "Correct. They all will be marked just like the three we have in service now. They'll all be marked identical to that." Then Mr. Reider said, "I understand. I know the last time we had a problem. All the officers were supposed to get them and it didn't work out quite that way." I don't understand what that means.

MR. REIDER: You don't understand that?

CHIEF MILHOAN: No.

MR. REIDER: Well, when we had a committee meeting—we had several committee meetings over cruisers, okay?

CHIEF MILHOAN: Yep.

MR. REIDER: Well, it was—and correct me if I'm wrong—

MR. BOND: I was on your committee.

MR. SHEELY: So was I.

MR. REIDER: The cruisers we were getting was going to replace officers that patrol—

CHIEF MILHOAN: That's not correct.

MR. REIDER: Yes, it—

MR. BOND: I think it was reflected in the proposed legislation—

CHIEF MILHOAN: No, it wasn't. The three cars you're speaking about are the ones that came from Florida. You're correct. We sat back here in this room back here. Bob was my chair. Mr. Sheely and yourself were back here on the committee. We discussed the three cars coming from Florida. Towards the end of the discussion, Mr. Bond specifically asked me. He said, "Chief, are all three of these vehicles going to be marked?" I said, "No, two of them will be, one of them will not." After that discussion, you made a motion to purchase them; Mr. Sheely seconded it.

MR. REIDER: Well—

CHIEF MILHOAN: That's exactly what happened back here. I can tell you where everybody was sitting.

MR. REIDER: Well, my point was this. I'm going to be plain and right to you.

CHIEF MILHOAN: Don, I've been plain to you—

MR. REIDER: Okay, now, you know what I'm talking about—

CHIEF MILHOAN: I do know what you're talking about—

MR. REIDER: We needed cruisers for our officers during patrolling, not for a Captain's position. Period. His car was a used car at the time. I understand that.

CHIEF MILHOAN: Correct.  
MR. REIDER: And we also discussed about purchasing him another car—  
CHIEF MILHOAN: A used car. That's correct. You gave me a budget. That's correct.  
MR. REIDER: In the meantime, that's how it ended up. So that's what I meant when I said that. It didn't work out quite the correct way.  
CHIEF MILHOAN: I felt that I was completely honest with the committee.  
MR. REIDER: That's why I made that statement because that's the way I felt about it—  
CHIEF MILHOAN: And they would all be marked—  
MR. REIDER: —because some of our officers got short changed. The ones that patrol all the time, not the ones that sit in the office—  
CHIEF MILHOAN: Don, you don't know what he does. With all due respect, you don't know what he does. That's all I have.  
MR. REIDER: That was my answer.  
MAYOR HILL: Any other questions for the Chief?

CHIEF EASTHAM: No report tonight, Mr. Mayor.
