Mayor's report. John Hickey from the Emergency

Management had a meeting the other day about funding for the Emergency Management Agency. I believe we've been paying \$699.72 for that. That's \$.21 per person who lives in the Village. And the way that is funded, each community, whether it be a township, city or a village, pays so much and then the commissioners also match that total. So, ours based on the census, is going to \$.30 per person. So ours is going from \$699.72 to \$999.60, which is an increase of \$299.88. They were supposed to have a meeting with the EMA Board. They were supposed to pass that the next day. I did not get it. But I believe they were going to pass that for \$.30. So,

Bill, there may be an increase coming.

MR. BLANK: Okay.

MAYOR HILL: And I have two Resolutions to accept from the Fire

Department and one appointment. That's it for the Mayor's report.

Is there a Clerk's report?

MR. BLANK: No report, Mayor.

MAYOR HILL: Is there a Solicitor's report?

SOLICITOR RIES: No report, Mayor. MAYOR HILL: Treasurer's report?

MR. EBLING: No report.

MAYOR HILL: Board of Trustees of Public Affairs report?

MR. PETERSON: Just that our regular meeting is tomorrow at 4:00 p.m., here.

MAYOR HILL: Thank you. Any questions for Chris?

CHIEF MILHOAN: No report, Mr. Mayor. MAYOR HILL: Questions for Brent?

CHIEF EASTHAM: No report tonight, Mr. Mayor.

Parks, Grounds, Buildings, Street Superintendent, Mr.

MR. HICKOX: Thank you, Mayor. We have received between 500 and 700

yards of mulch. We've been mulching the walking trail up at

the park, and we are just about completed with that.

We've been mowing the grounds and the roads. We have our one road mower back in service. So, we're trying to catch up

on that.

We're repairing traffic lights on Hallock-Young Road.

We've installed the road pipe for two residents.

We're gearing up and helping with the Cider Festival this

weekend.

We've seeded the last sections of pond that was dug up when it was redug. Got grass growing there now.

I'll be attending the Ohio Public Works Commission meeting tomorrow on the Hewitt-Gifford Road paving project.

That's all I have.

Thank you. Any questions for Ron?

(NO RESPONSE FROM COUNCIL.) Bill, do we have any correspondence?

MR. BLANK: No correspondence.

> MAYOR HILL: Public remarks. If you'd like to make a public remark, after I acknowledge you, please come to the microphone and give your name and address so we can get it

recorded in the minutes correctly. Yes?

MR. MADERITZ: John Maderitz, 2700 Virginia Drive, Lordstown. We got this

one little problem—Arno, I talked to you and I talked to Ron -about this drainage ditch behind our property where Lordstown also kept care of it, kept it cleaned. When Dale was here, we never had a problem with it. Well, for the last seven years, no one has touched it. Now we've got families coming around with kids and all that. And we've got baby raccoons during the day, skunks, everything running right up in her yard coming right from the drainage ditch. Now, that drainage ditch comes from under the road with, like, a threefoot pipe there. And I guess—I was kind of told I was responsible—we were responsible for that.

It all started out when I called. I called you and you told me to get ahold of Ron. He told me it was wetlands. They weren't allowed in there to do anything. Never heard of that before. I called the Army Corps, talked to them, had a letter presented here that—maybe Christy came—it is not wetlands. There is no wetlands there. So, after I proceeded that, I was also told that we owned it, which I showed Ron where my stake was. I don't even come near owning that. But he proceeded to tell me they would need permission. So, he came over, we signed papers. Christy and I both signed papers giving them permission to do what they got to do.

Now, all of a sudden he came to our house a couple days ago and asked him did you get ahold of the EPA. He told me he had to get ahold of the EPA. He said no. I've got to get ahold of Council and Council has to give him permission to go in and clean that out.

Now, that culvert, it runs through the whole complex. It actually dumps all the way down there all the way through the roads, a big pipe comes out and goes right down into the farmland down there into a pond.

Now, I did ask a question, if I own that land, can I build a dam on that land to stop the water from even coming into my property? I was told, well, I guess you could. Which is really kind of stupid. I also told one Councilman—this was before, I think, seven or eight years ago—that is was a mosquito-infested pit back there and he told me, well, back in 'Nam he got a can of oil and opened it up and threw it in there and that killed all the mosquitos. I proceeded to tell

him to say Vietnam, you know. So, now we're talking about getting ahold of the EPA doing this and years ago we're talking about throwing oil in.

The whole problem with this—because I never complain about nothing. The whole problem is we got kids there now. She has 10, 12 kids in her yard every day playing. You got raccoons coming right up in the driveway. One of these little kids is going to try to pet a raccoon or do something. I guess we gotta wait until the accident happens before we fix it. All I'm asking is that they go down there like they used to. They get a brush hog down there, clean it out. I'm not asking to cut trees down or nothing like that. Clean the brush out where it starts under the road and continue down. I really don't see why I even have to be here for that. To me this is really stupid.

Also, while I'm here, I'll just say one thing. I'm not a complainer. I bought my house 25 years ago. I was the first one down there. The agreement I have in my hand states there will be sidewalks put on both sides of the roads. There will be a streetlight at the end of my road. There will be a culvert because when we built my house the city and Trumbull County told us run it out to the road. There's going to be a catch basin out there. That's what we did. No sidewalk—25 years later no sidewalk, no catch basin, no streetlight. And I never said a word. I don't even care about it. But this is really stupid that I have to come down here to ask help to get a drainage ditch cleaned out when I see them all the time going up and down Salt Springs, cutting it down.

That's all I got but this is really stupid that I have to be here for this.

MAYOR HILL:

I know you've called me many times and I've talked to Ron and I've talked to the Solicitor, and Council is aware of what this problem is. I know you did sign where we could go on the property, correct? And Ron said if he had permission from Council, he would do that. What's Council—

MR. MOSELEY: Whose property is—

MAYOR HILL: What?

MR. MOSELEY: Whose property is that where that is?

MAYOR HILL: Well, we've had areas in the past where when there was a

waterway through there, we have gotten permission—am I

correct when I say that, Bill?

MR. BLANK: I don't know.

MAYOR HILL: We have. They went through the whole Village years ago.

There's—

MR. BLANK: Yeah, that time—

MAYOR HILL: And there's other times when we have gone and cleaned out

waterways or ditches or something like that as long as we had a release signed from the resident saying you could go

there. Now, Ron says—

MR. RADTKA: So, this is beyond the road right-of-way.

MR. HICKOX: Correct.

MR. RADTKA: So we're cleaned out from the road right-of-way to this

point?

MR. HICKOX: The pipe he talks about, the three-foot pipe, ends at the right-

of-way.

Oh, okay. MR. RADTKA:

It comes right out at the road right there. MR. MADERITZ:

MAYOR HILL: So, they signed off to let the Village go on that property, but

the pipe ends at the road property and what is there, maybe a

couple hundred foot at the most, John?

MR. MADERITZ: Yeah.

MAYOR HILL: Couple hundred foot where they'd like to have them come in

and brush hog. Now, I don't know if that was brush hogged before. He said it was. I don't have any reason to deny what

he's telling me.

They did it for probably 15 years, 16 years. MR. MADERITZ:

MR. MOSELEY: Well, how does that get rid of the animals if they clean out

the ditch?

MR. MADERITZ: The animals now are living right—she hired a trapper, spent

> \$500. They set traps right at the road there, at the culvert where they come out and right up into the trap. They are living in there now. Once that's cleaned out, we can actually pretty much try and keep it clean. I used to keep my mine cleaned all the time. Then I had a stroke and it came to the

point where I couldn't go down that hill.

MR. MOSELEY: Well, what about when it fills up with water, does it wash all

the animals out?

MR. MADERITZ: When the water goes down, it's supposed to flush. That's

> what drainage does. It flows right down. I mean, you're talking—here's my point, you people are saying I own it. She owns it. She decides to stop that water in her backyard. I decide to stop it this way (indicating with hands), now, you've got all Mary Drive that your drains come down there. On the other side of the road in Julia allcut right down there. So you guys are saying if I clogged all that up, the water has nowhere to go. Where's it go? Again, where's it go? I'll give you a prime example where it goes. My sewer at the end of my street and then Krisher owns all

that land down there. I get along great with him.

Trucks go in and out down there. There's a sewer down there. One of the trucks, I guess, caved in the sewer. It got filled up with concrete, brick. Where'd that water go, that sewer water? Right in my basement. It backed all the way up. I called the city of Lordstown. City of Lordstown told me Trumbull County owns the sewer. I called Trumbull County, he came out. They came out real quick and cleaned it out and told me what happened. But he also told me, yes, anytime you have a problem with the sewer, we own the sewer drains. He said when you have a problem with storm drains, you call the city. That's what I did. I called the city. So, you guys take it from there what you want to do, but I just don't understand how it can be such a big problem.

I think there is a request on the table. If you want to bring

this up and discuss it under old business and see if you want to do something. I have a recommendation. You guys do

what you feel like.

Any other public remarks? Yes, sir. MAYOR HILL:

MR. PUHALLA: I don't know if you want me up to the microphone, but I'll do it. For the record, Leo Puhalla, P-U-H-A-L-L-A, for the
